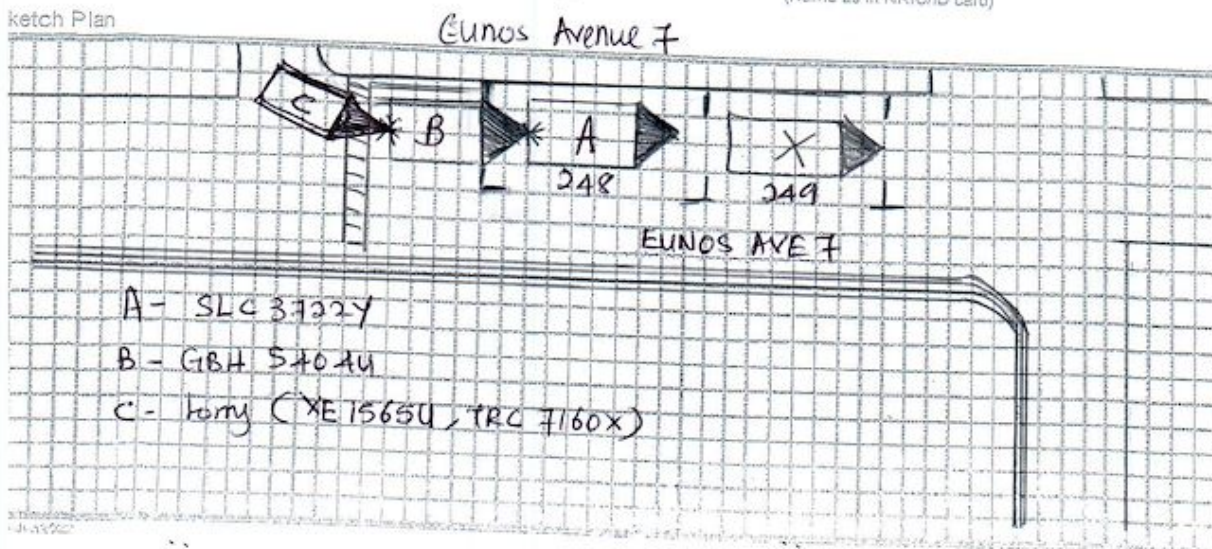

## Description of the Accident

My vehicle was parked along Eunus Avenue 7 at lot 248 on the above stated date and time. It was parked in front of my office unit NO. 01-127. I heard a loud bumping noise, so I went out to check and I saw a van hit to my rear portion of my vehicle but there was no driver in the vehicle.
