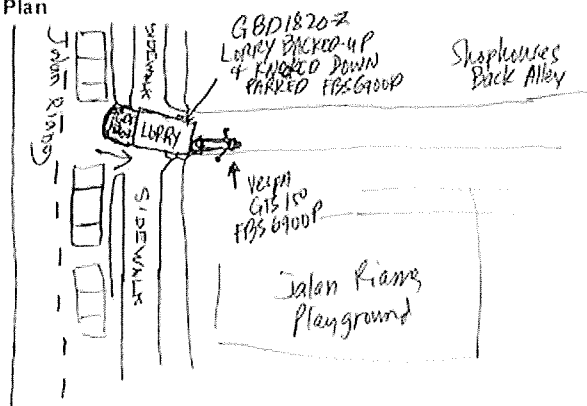

Describe Circumstances of the Accident

On April 2nd, 2023, Lorry GBD 18202 backed-up and then knocked down PARKED motorcycle FBS 6900P along Jalan Riang - specifically back alley of shophouses along Jalan Riang. This is adjacent to Jalan Riang playground. The Lorry driver, Mr. GOH HOCK LYE with NRIC S7230123D and Driver's licence Serial No. 001149384C and resides at 2 LORON ZEW LIAN #14-54, Singapore 531002, straight away backed up and knocked down FBS 6900P at time of around 7:15PM Singapore Time.

The Lorry particulars were taken and is insured by AIG with Policy No. 722.0062327 for the period 01 Jun 2022 to 31 May 2023. Witness can be provided upon request as owner was present as well as people at Jalan Riang playground. Lorry Driver's contact No is (+65) 90899099.
