THEN I SIGNALLED TO FILTER ONE LANE TO THE LEFT AT VERY LOW SPEED AND THEN AS I SLOWED DOWN TO JOIN THAT LANE, MOMENTS LATER I HEARD A LOUD BANG ON THE REAR RIGHT OF MY VEHICLE SO I GOT OUT FROM MY VEHICLE AND FOUND THAT VEHICLE B SMM4176C HAD BANGED ON MY REAR RIGHT OF MY VEHICLE. THEN UPON CHECKING THE REAR CAM OF MY VEHICLE IT CLEARLY SHOWS THAT DRIVER OF VEHICLE B SPEED UP INSTEAD OF SLOWING DOWN THUS CAUSING THE ACCIDENT. I HAVE TO MENTION THAT THE CAPTURED VIDEO TIME STAMP IS WRONG AS IT KEPT RESETTING TO 2021 BUT ITS INDEED THE VIDEO FOOTAGE FOR THE ACCIDENT.
