I wish to state that it was a chain collision of total of 3 vehicles involved.

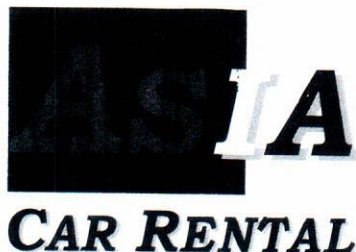
