ON 9 APRIL 2023, AT 3.30 PM. VEHICLE SCX6000Z (A). TRAVELLED FROM BARTLEY ROAD TOWARDS UPPER SERANGOON ROAD. GOING TO MAKE A LEFT FILTER INTO UPPER SERANGOON ROAD. THERE WAS A GOODS VEHICLE (GBJ6714H) (B), TRAVELLING IN THE SAME DIRECTION IN FRONT TOWARDS THE BEND INTO UPPER SERANGOON ROAD. B WAS ABOUT 10 METERS IN FRONT OF A. VEHICLE B SLOWED DOWN TOWARDS THE BEND, LOOKING OUT FOR ONCOMING VEHICLES FROM THE RIGHT TRAVELLING ALONG UPPER SERANGOON ROAD. VEHICLE A SLOWED DOWN BEHIND VEHICLE B. SHORTLY AFTER THAT. VEHICLE B ACCELERATED TRAVELLING INTO UPPER SERANGOON ROAD. VEHICLE A FOLLOWED BEHIND. HOWEVER, VEHICLE B CAME TO A COMPLETE STOP, AND VEHICLE A WAS NOT ABLE TO STOP ON TIME AND HIT THE REAR OF VEHICLE B.

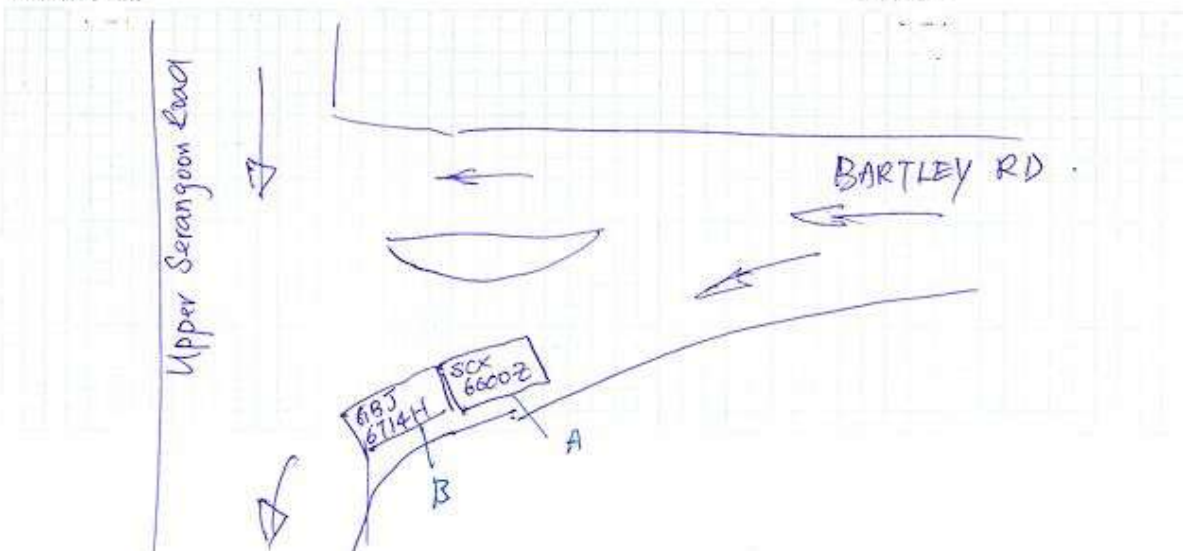

Describe Circumstances of the Accident

On 9 Apr 2023, 3.30pm. Vehicle SCX6000Z (A) Travelled from Bartley Road toward Upper Serangoon Road, going to make a left filter into Upper Serangoon Road.

There was a good Vehicle (GBJ6714H) ~~to~~ ~~from~~ (B) travelling in the same direction in front toward the bend into Upper Serangoon Road. B was about 10 meters in front of ~~A~~. Vehicle B slowed down toward the bend, looking out for on coming Vehicles from the right travelling along Upper Serangoon Road.

Vehicle A slowed down behind Vehicle B. Shortly after that Vehicle B accelerated travelling into Upper Serangoon Road. Vehicle A followed behind.

However, Vehicle B came to a complete stop, and Vehicle A was not able to stop on time and hit the rear of Vehicle B.
