

Schematic Diagram of Incident






Figure 1A: Schematic Diagram




Figure 1B: Schematic Diagram

II (Statement)

 On 060423 at about 2130hrs, I, CPL PANG JUN EN JAVIER, TXXXX144Z, was driving Military Vehicle (97148MID). We were traveling back from Sungei Gedong Camp to Selarang Camp in convey movement of 5 vehicles with me being the 3rd vehicle after 3SIR BME for ARF manning.

During the time of the incident, we were travelling along the left most lane (lane 4) of 4-lane expressway and was already moving very slow due to a congestion and I had approximately 2 to 3 civilian car lengths to the other Belrex convey vehicle in-front of me, when along the BKE heading towards the Woodland Ave 3, before SLE Exit 8, at the end of the left filter lane from Mandai Flyover, the civilian vehicle involved in the incident decided to abruptly cut into my lane in between me and the convey Belrex in-front while we were traveling on the expressway with him filtering into us.

Prior to the point of impact, I was focusing on the road conditions ahead as I was travelling straight and traffic was building up due to works ahead. As such, I was driving at a slow speed of 15km/hr to allow sufficient space between myself and the vehicles in front.

The civilian driver (SNH6095D) was coming up on our left through the filter lane. He decided to stick close and forced his way into the highway from the filter lane which resulted in the collision between the rear of the civilian vehicle and the front of the military vehicle.

I immediately stopped my vehicle from the impact and my vehicle commander went down to talk to the guy involved. Luckily there were no one injured with damages only to the civilian vehicle (SNH6095D). The civilian vehicle driver involved was still able to get down from his vehicle to exchange particulars and take photos of the incident.

I declared that this statement was written truthfully.

II (Statement)

 I, 3SG CHIA ZHEN HONG, RYAN, TXXXX587H, on 060423 at about 2145hrs, was involved in a traffic accident involving Military Vehicle, Mortar Belrex (97148MID) and Civilian Vehicle (SNH6095D) along BKE towards Woodlands Ave 3, before Exit 8 while enroute back to Selarang Camp (SLC) from Sungei Gedong Camp (SGC).

During this detail, I was the vehicle commander for CPL PANG JUN EN JAVIER who was driving the vehicle back to SLC. We were PRD-ing back to Selarang Camp from Sungei Gedong Camp as part of our post BME process and for the vehicle to return to Selarang Camp for ARF manning. We were moving in a convoy of 5 x Belrexes consisting of 2 x Belrex Mortar Ammo Carriers (BMACS) and 3 x Belrex Mortars. The convoy was moving along the BKE heading towards Woodlands Ave 3 just before the SLE Exit 8 where we were supposed to take.

Prior to the incident, we were travelling on the left most lane (lane 4). There was approximately 2 and a half civilian vehicle space between us and the Belrex in front of us in the convoy. We were moving below 15km/h as the congestion at the time was really bad. Civilian vehicle came in from the left of our vehicle. Civilian was driving very closely against the Belrex. Both the driver and I were doing our best to navigate the congestion ahead of us. The civilian vehicle came into our lane abruptly. The first collision happened when the civilian cut into our lane from the left. The left side of our vehicle came into contact with the right bumper of the civilian vehicle. We could not hear the impact as we were moving slowly as there was a jam on the BKE at the time of the occurrence. At this point, we are still unaware that we have collided into the vehicle as we could not see it nor hear the contact due to reinforced structure of the Belrex. At this point, the civilian vehicle were too close to our vehicle that he was not visible to me or my operator. After the first contact the driver continued to move into the lane and we performed an emergency stop drill and my operator stop immediately but still resulting in the trunk of the civilian vehicle making contact with the front bumper of the Belrex. breaking the glass panel on the civilian trunk, resulting in the 2nd collision. I made a call to my platoon commander before exiting the vehicle to inform him about the situation.

Upon exiting his vehicle, the civilian pulled out his phone to begin to video record me. I exited vehicle to firstly, put a warning triangle on the back of vehicle and exchange contact details with him. Shortly after, CPT Gabriel arrived with CPT Vimal to assess the situation and 2 traffic police officers came to disperse the vehicles involved to clear the congestion. No one was injured in the process. The civilian vehicle was carrying the driver and a passenger while the Belrex was carrying a driver, vehicle commander (myself) and 2 cabin passengers. No visible damage was inflicted on the Belrex.
