

**Brief Details.**

I was driving along TPE, past the Sengkang East Exit, going straight on Lane 2, when a lorry GBD1792X entered the expressway, and the lorry was behind an SBS bus. Upon entering the expressway, the lorry driver immediately changed into my lane (Lane 2 from Lane 3). I high beam to give a warning i could not slow down in time to give way to him, but he still continued with the lane change. I had to quickly swerve to my right (into Lane 1) in order to avoid collision. Fortunately, there were no vehicles in Lane 1 at that time. However, there was a fast approaching car which flashed his high beam due to my sudden lane change. I quickly accelerated ahead of said lorry (GBD1792X) as I had to quickly swerve back into Lane 2 again, in order to avoid possible incoming collision with the fast-approaching car in Lane 1. However, the said lorry failed to slow down in time for me, even though i signalled my intention and was ahead of him. This caused a collision between his lorry's side mirror part, with my lorry's rear part.
