

CONTINUATION OF REPORT

**Brief Details.**

On 30/03/2023 at around 1215hrs, I was driving my vehicle bearing licence plate : White colour lorry GBD1792X Toyota Dyna and was travelling with my 2 passenger at TPE Towards SLE at Punggol Way exit.

I was travelling at Lane 2 on the expressway. Subsequently, I saw vehicle bearing licence plate : GBK2268A , white Toyota lorry was travelling behind me on Lane 2 on my rear mirror.

GBK 2268A then filtered onto lane 1 and subsequently filtered onto lane 2 in front of me. I affirmed that the driver did not indicate its signal light. Subsequently, GBK 2268A's left rear side collided onto my front right side.

The driver of GBK 2268A then left the accident scene without stopping. I tried honk at him multiple times however the driver already fled.

I affirmed that there were no injuries on me and my passengers. There were no traffic police and ambulance attended the accident.

I wish to state that my vehicle sustained a damaged right side mirror, damaged front right signal light, front bumper and front right door damaged.

I am lodging this police report for record purposes.
