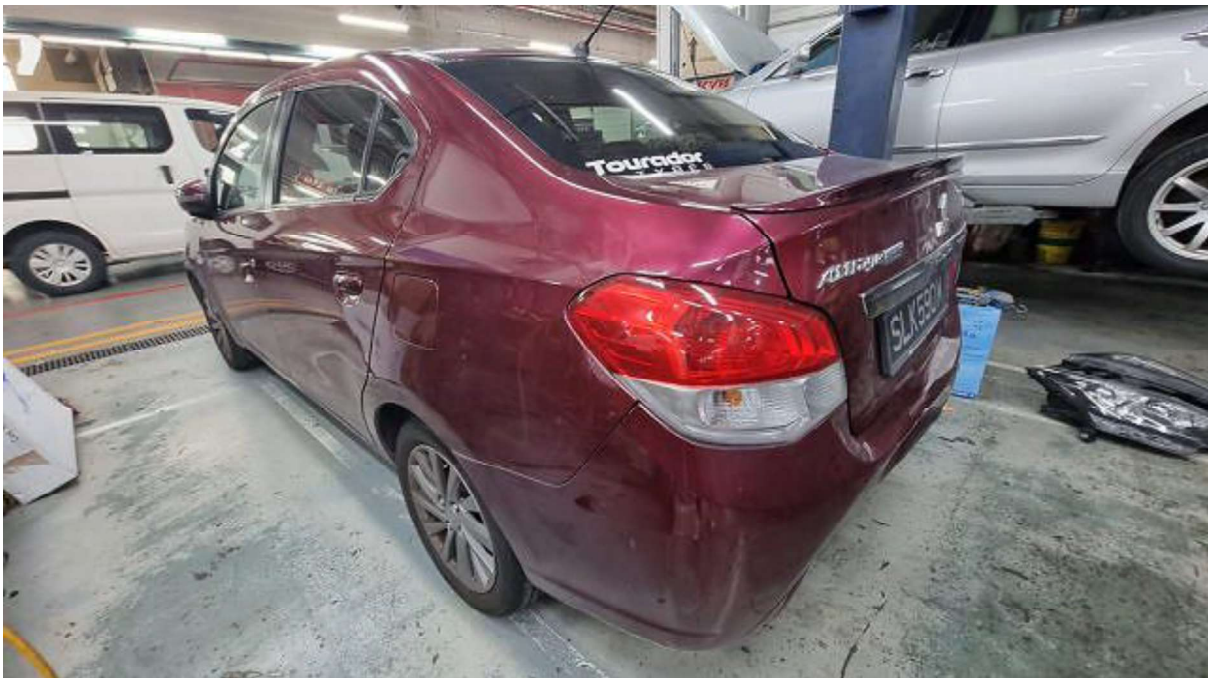

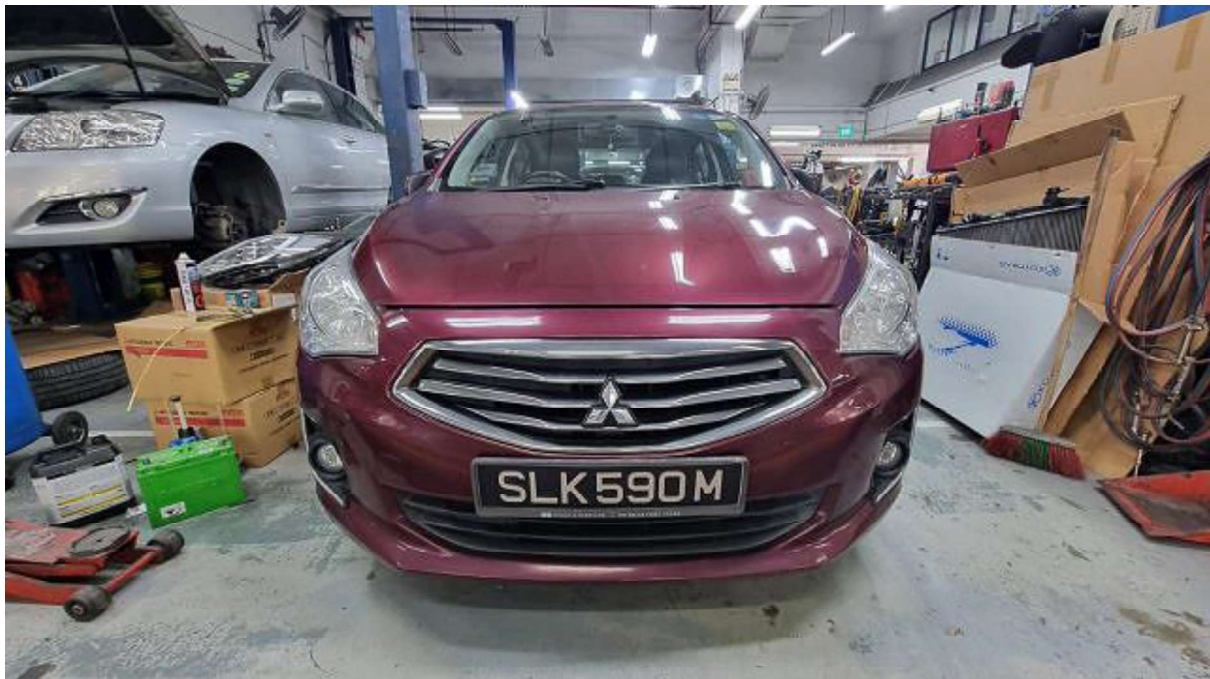

On 12/04/2023 at about 5.30 p.m, I and my daughter Ng Lee Yin felt pain on the neck. We had went to Kings Medical Clinic to see doctor, we were both given a total of 7 days medical Certificate dated from 13/04/2023 to 19/04/2023 MC no 0000002922 and 0000002921. My daughter had already lodged a traffic police reference T/20230412/2145.

My vehicle had then came to a complete stationary stop, behind my vehicle was SNC6932P, the vehicle had also came to a stationary stop. However, vehicle GBK3724T which is behind SNC6932P did not came to a stop and hit onto it rear, this resulted on vehicle SNC6932P hit onto the rear of my vehicle.

We then came out of our vehicles and take pictures of all the involved vehicles. I did not manage to take down the other parties particulars as it was a busy road at CTE. No one was injured at the point of time. No ambulance nor any traffic police had came. My vehicle boot was totally damaged and I do not know the cost of the damage. My vehicle had an installed in built CCTV camera and had captured the whole accident.

On 12/04/2023 at about 5.30 p.m, my mother Ngo Giok Tjoe and I had felt pain on the neck. We had then went to Kings Medical Clinic to see doctor, we were both given a total of 7 days medical Certificate dated from 13/04/2023 to 19/04/2023 MC no 0000002922 and 0000002921.
