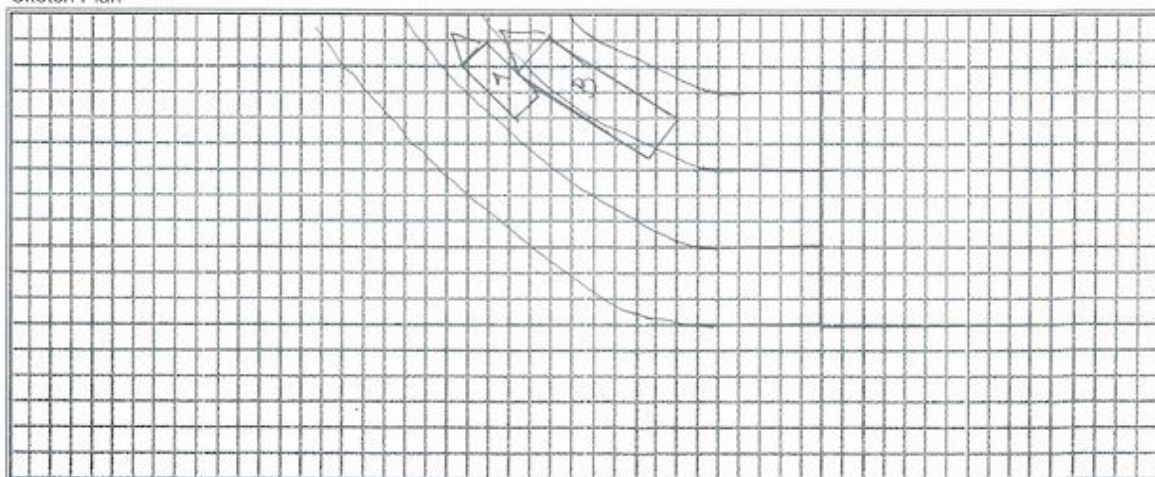

Describe Circumstance of the Accident

On 20th March 2023 at about 8.35 to 8.40am, I was stationary at the traffic light turning right to Bradell Road near the flyover. I was at the middle lane. When the traffic light turns green, I slowly proceed to turn right as there's a car in front of me. I was driving at a speed of about 20-30km per hour and suddenly I felt an impact and heard a 'bang' noise. I looked at my right rear view and saw a lorry hit the right rear ^{of the} side of my car. I am very sure and certain that I was in my lane as I can still see the dotted lines on my right.

I proceed to drive slowly as the traffic was really busy and I could hear couple hon sounds. I then drove to the left lane and drove to the nearest bus stop. It was there I then realise that my car right rear door was dented and we exchange air particulars. I wish to state that this is my daily route that I travel to work ^{almost} everyday and understood the business of the traffic. The driver on the other hand of vehicle XE 543P seems in a hurry and does look pale and was busy calling and texting his mobile. I have to wait a while before he surrender his ID and driving licence for us to take pictures.
