

I was going straight along Paya Lebar Road, Junction of Ubi Ave 2. I was filtering to mine right (Going straight lane) as I was going to turn right at the next junction (Ubi Ave 3). The white Toyota Yaris

Cross e-braked on the green traffic light.

Had a head on collusion with him.

Upon the impact, we on hazard light to warm the traffic. I had went down to check if the driver was injured. The Toyota Yaris Cross driver came out of his car, ambulatory, fully conscious, no visible physical injury noted.

We then agree to drive further down the road to exchange details without obstructing the traffic.

Upon exchange details, Mr Adly claims that he felt his left knee was painful and he needs to go see clinic. I offered him to get an ambulance, however he refused.
