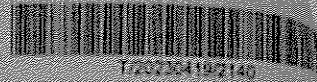

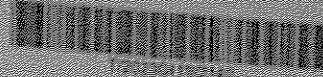
During the accident, the damage to my vehicle was on the rear left portion and the cost of repair is unknown.

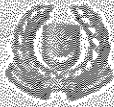
I am lodging this report as there are amendments to my previous report lodged under T/20230419/2140.

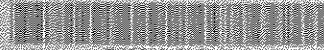
