

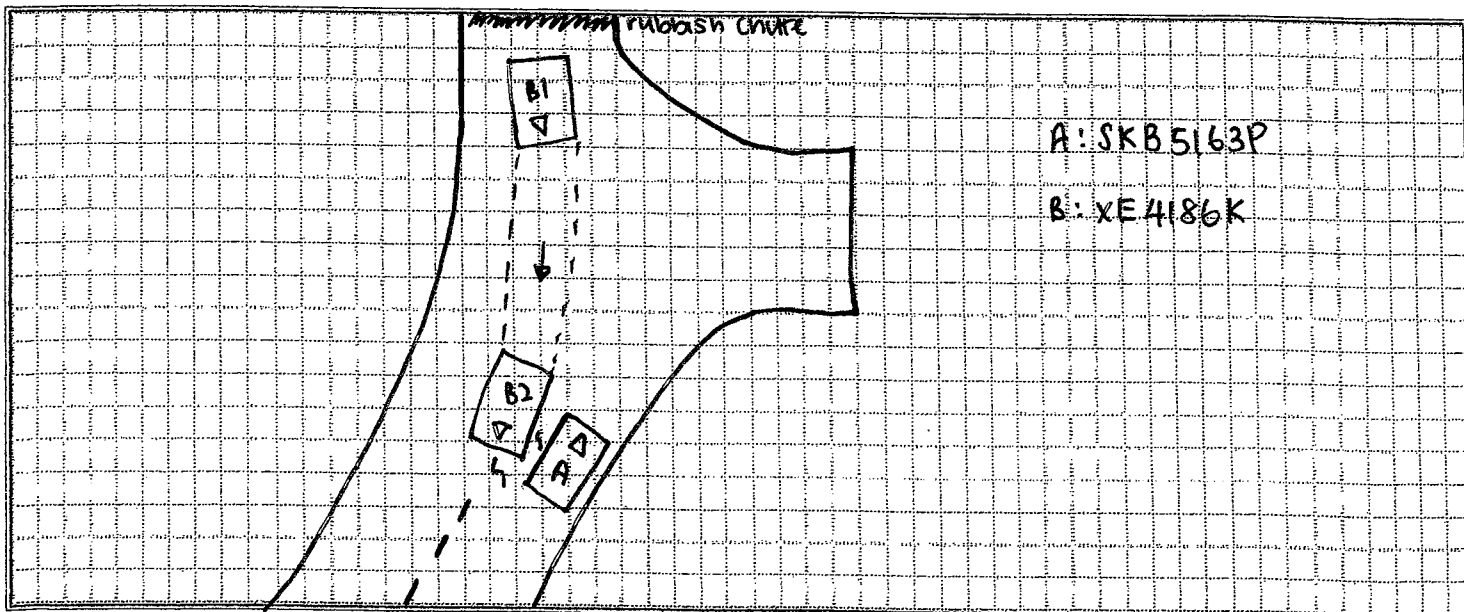

Sketch Plan





Describe Circumstance of the Accident
