




Describe Circumstance of the Accident

Traffic lights red and all cars were stationary. After confirming that all cars have stopped, I proceeded to move into the yellow box and stopped again to check for any on-coming motorbike and moving cars. When I have confirmed that it is safe and car B (which was on lane 2) was also stationary and he left a very big space between his car and the car in front, I proceed to enter into Lane 2 at a very slow speed.

While doing so, car B suddenly move forward and his car hit onto the RHS front portion of my car.

Not to obstruct the traffic, we moved our cars to the side of the road before we alighted to take photos and exchanged particulars. Driver of car B mentioned that he is unable to see my car when he moved. He has also offered to have private settlement if my repair cost is between \$1k to \$2k, but if too much will have to go thru insurance. I came to Borneo Motors for an assessment and informed him that I will be claiming his insurance




