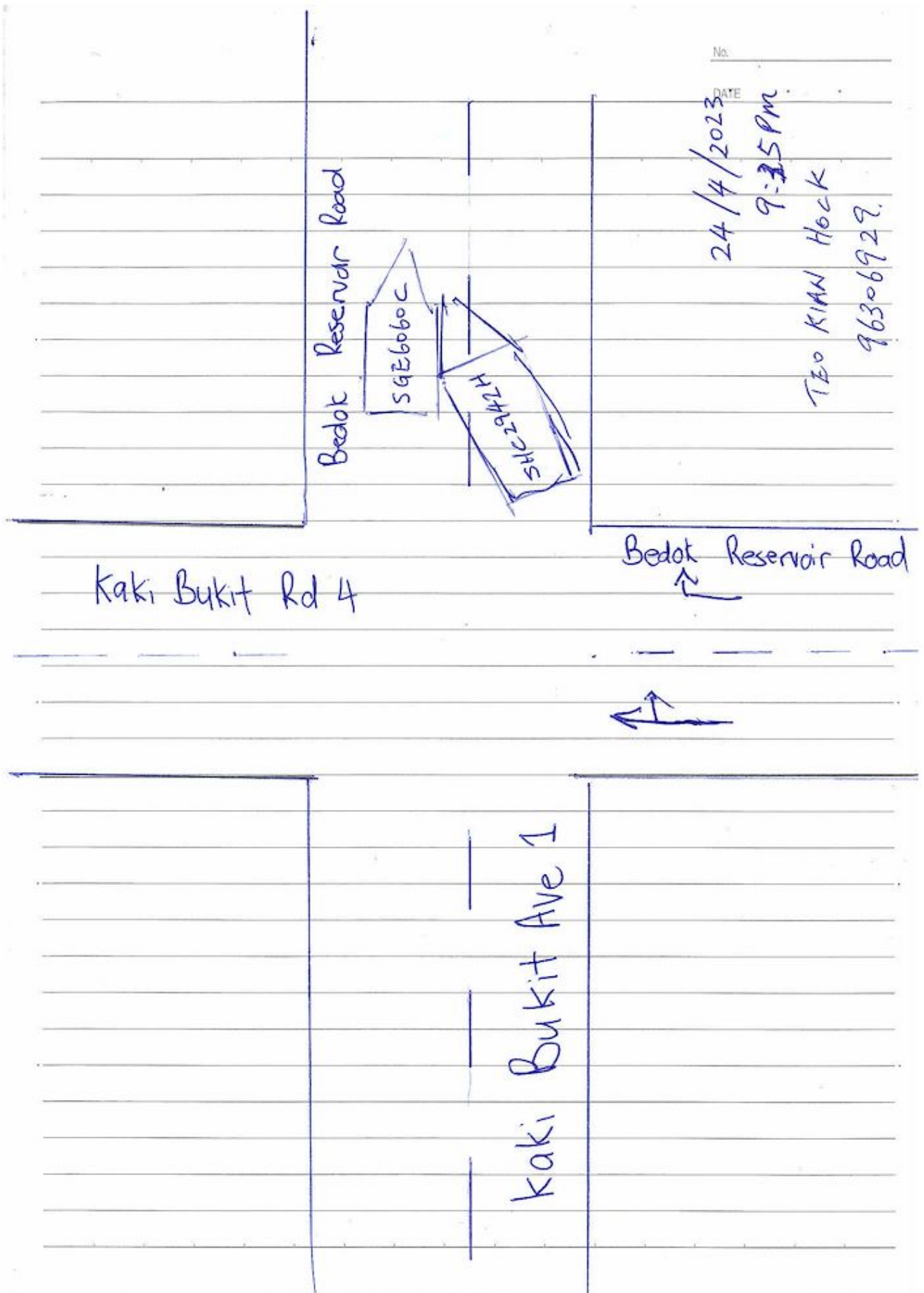

 bumper.

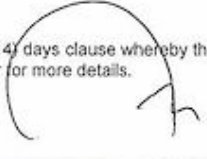
