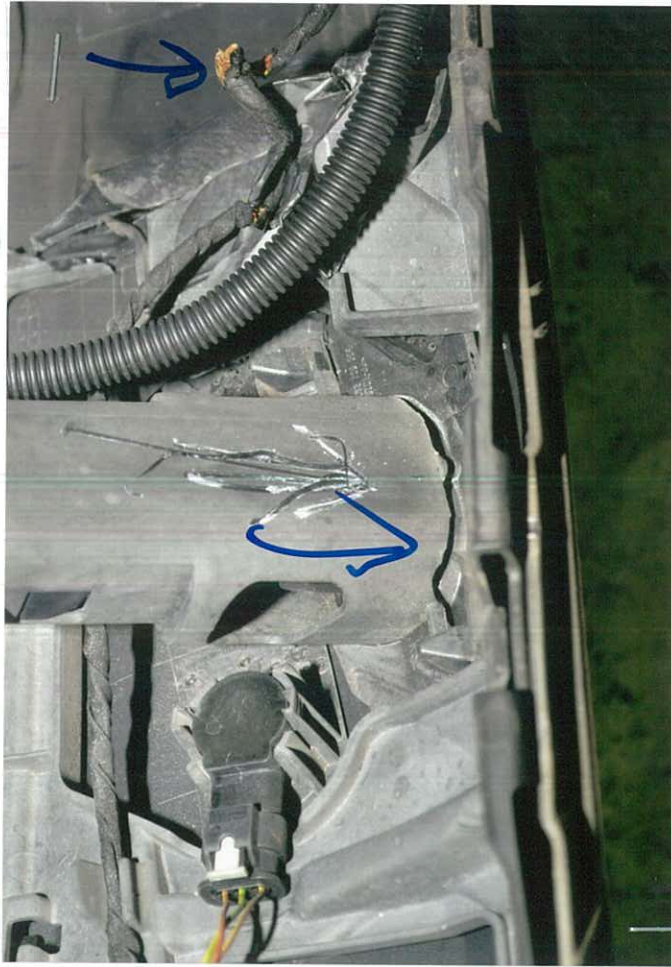
Disassembly of engine parts
