CONTINUATION OF REPORT

On 19/04/2023, between 2:10pm, to 2:15pm, I was driving my company bus PA9997U along Pan Island Expressway and was heading towards Bukit Batok West Avenue 8. Somewhere near to the Adam Road exit, I came across a black in colour car SNE6809C which had tried to overtake me from my right. As the said car overtook my bus closely, I changed lanes to my left to avoid colliding into the said vehicle. I then honked the said vehicle to inform him that he had almost knocked into my bus. I had also flashed my headlights at him to alert him to what he had done. The driver of the said car then kept changing lanes and overtook me a few other times.

Subsequently, somewhere before the Upper Bukit Timah Road exit/Clementi Road exit, the said car got too close to my bus and hit onto the right side of my bus. After knocking onto the right side of my bus, the said car then sped off and I could not see where he had gone off to. I then took the Bukit Batok exit as I had to pick up some school children at Dulwich College at 2:30pm. After I parked my bus, I saw that there were a few long scratches and a few dents on the rear right side of my bus.
