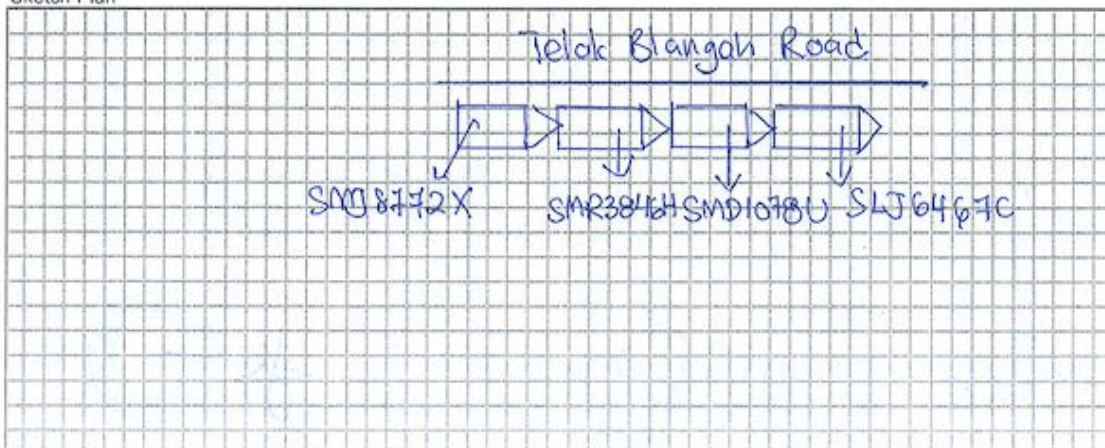

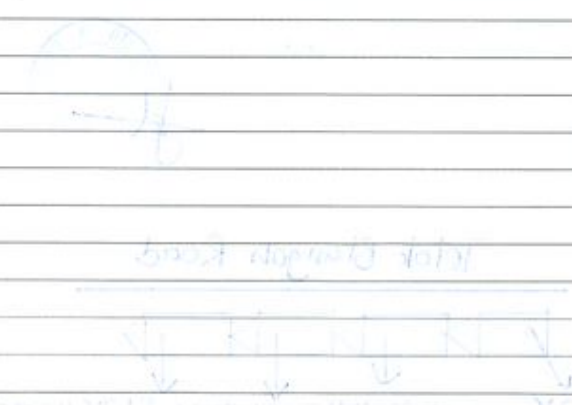
Sketch Plan
