



Sketch Plan



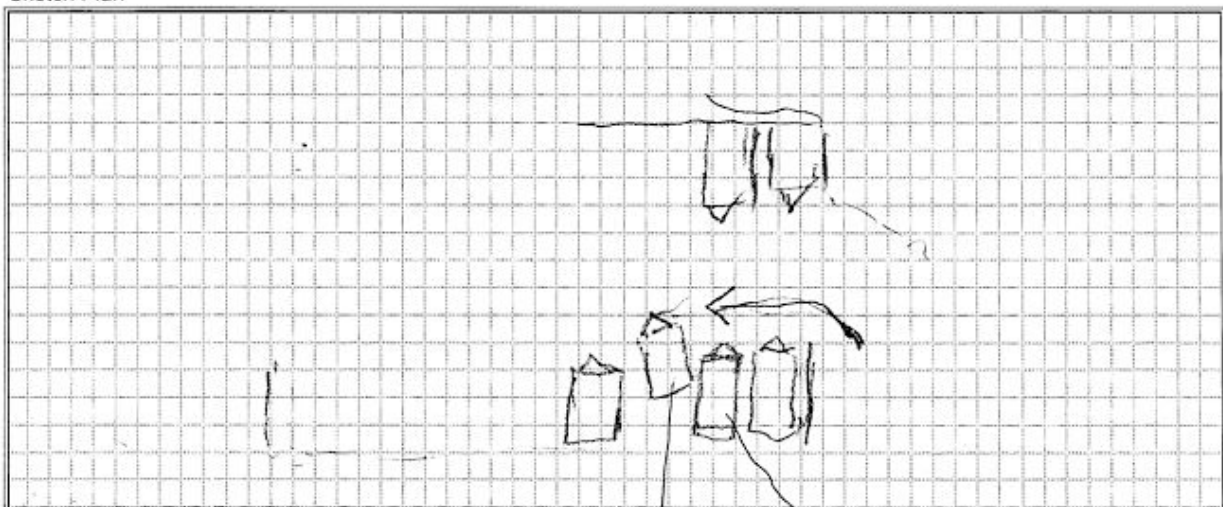
