



Sketch Plan



## Describe Circumstances of the Accident:

I was negotiating a U-turn from Bukit Timah Rd onto Dunearn Rd to travel southeast towards the junction with Chancery La/Balmoral Rd.

I glanced to the left to look for any oncoming traffic on Dunearn Rd and saw none so proceeded to turn onto Dunearn Rd. Next thing I heard a loud bang and realized there had been a collision.

A grey metallic painted Mercedes C18 saloon (car license plate no. SLS 7744L) was now stationary some 50m down Dunearn Rd in front of my Audi A8L (license plate no. SLS 7039B).

I proceeded to pull-up behind the Mercedes put on my hazard warning lights and placed the warning triangle some 50m behind the vehicles.


Upon reaching the Mercedes I realized that the two cars had collided. The driver a Mr Lionel Han was driving and had his daughter (a child of maybe 7 years of age) in the front passenger seat.

We exchanged details and took photographs of our respective vehicles and the scene;
