

#### Brief Details.

On 29/04/2023 at about 1725hrs, I was driving my vehicle, Toyota Vellfire, SMP3871U along Bencoolen Street towards Fort Canning Road at the junction of Stamford Road. I was driving along the second lane, and was going straight, when suddenly a car with registration number SLB3001A, from the first lane, on my right, suddenly squeezed into my lane as she was also trying to go straight instead of turning right. The first lane was designated for right turn only.

The car then hil on to the right side of my vehicle. There are multiple damages on the right side of my vehicle. I alighted from my vehicle as I checked for the damages, however, the driver of the other vehicle did not want to alight from her vehicle to exchange particulars. I told her that she was not supposed to go straight, but she was not bothered and told me to claim through insurance and she just drove off. There was also a passenger beside the driver at that time.

At that point of time, there was a passenger in my car sitting at the back. My passenger was not injured, however, I felt pain on my body.

At about 2150hrs, I went Mount Alvernia Hospital to make a check, and was granted 7 days of sick leave for my injuries.
