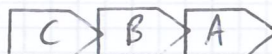

C: SJU3681K




Describe Circumstances of the Accident

SUDDENLY, VEHICLE C (SJU3681K), REAR-ENDED VEHICLE B, CAUSING VEHICLE B TO SURGE FORWARD AND COLLIDE WITH THE REAR PORTION OF MY VEHICLE.
