## Describe Circumstances of the Accident

On the day of 4 of May 2023, I left home to be on my way to Marina Bay Sands for a seminar, I entered AYE from Clementi Road entrance, after entering AYE I switched lane to the third lane. The traffic was heavy. I was driving at about 60-70 km/h.

After South Bann Vista exit, there was a taxi wh. jammed break in front of Car C that Car B jammed break, I immediately jammed break and the car skidded couldn't stop in time which collided into Car B. I was worried that the car behind a white Land Rover also almost hit my back. Stayed in the car for a few seconds.

Thereafter, I came out of car to check the consequences of the accident. I asked if they were ok the driver of Car B came out to take photo while the passenger was out to video the accident. I saw Car C was totally ok with a small scratch on bumper. Car B too had a small scratch on front bumper but his rear was damaged.

Driver of Car C said a taxi jammed break in front of her so she did and Car B jammed break and got me to also jammed my break but I couldn't stop in time.

We exchanged drivers particulars and numbers, I cleaned the car debris on the road and left the scene.
