Brief Details.

On 05/05/2023 at about 1600hrs, I am riding V1: FBN7540P travelling along Old Toh Tuck Road towards Toh Tuck Road East (Two Way Road, One Lane). At that point of time, I was travelling at about a speed of 40km/h and the traffic was clear. After I rode past Toh Tuck Link, V2: SHC3042Z turned right from the Toh Tuck Link (Minor Road) to Old Toh Tuck Road (Major Road) and collided onto the rear right of V1 which resulted me to fall to my left.

Subsequently, V2 came down to render assistance and we have exchanged particulars and took photos of the accident. At that point of time, no one required any medical assistance, thus, no traffic police or ambulance came to scene. Both of us left the scene afterwards.

At about 1830hrs, I went to seek medical assistance (ICON MEDICAL CLINIC) as I felt some pain on my body and was granted 03 days of MC from 05/05/2023 till 07/05/2023 date inclusive (MC NO: 0000077842). Doctor prescribed me with painkillers. V1 have a camera recording. V1 sustained scratches and dents on the left side and scratches on the right exhaust.
