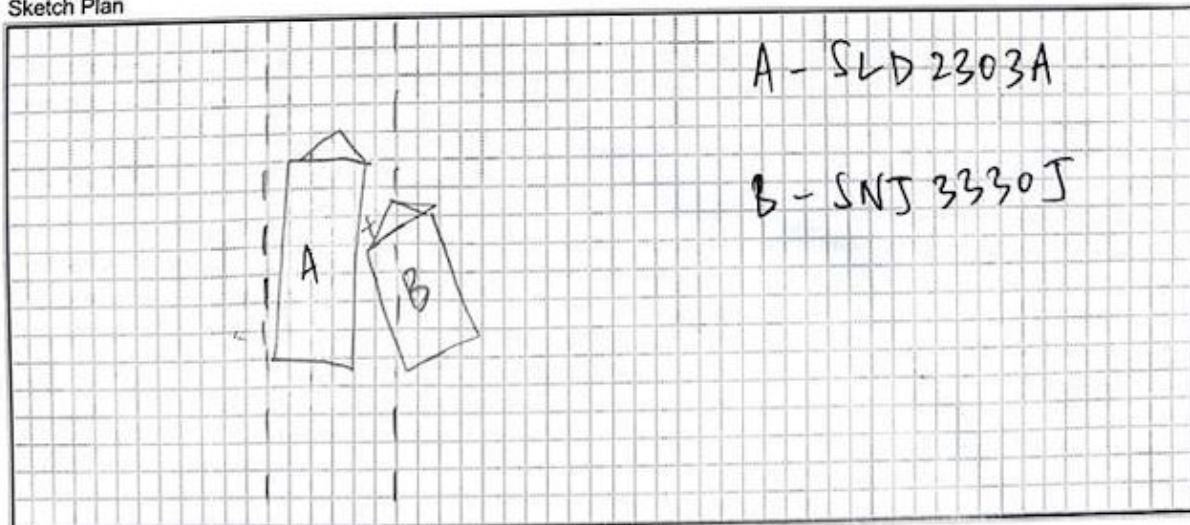

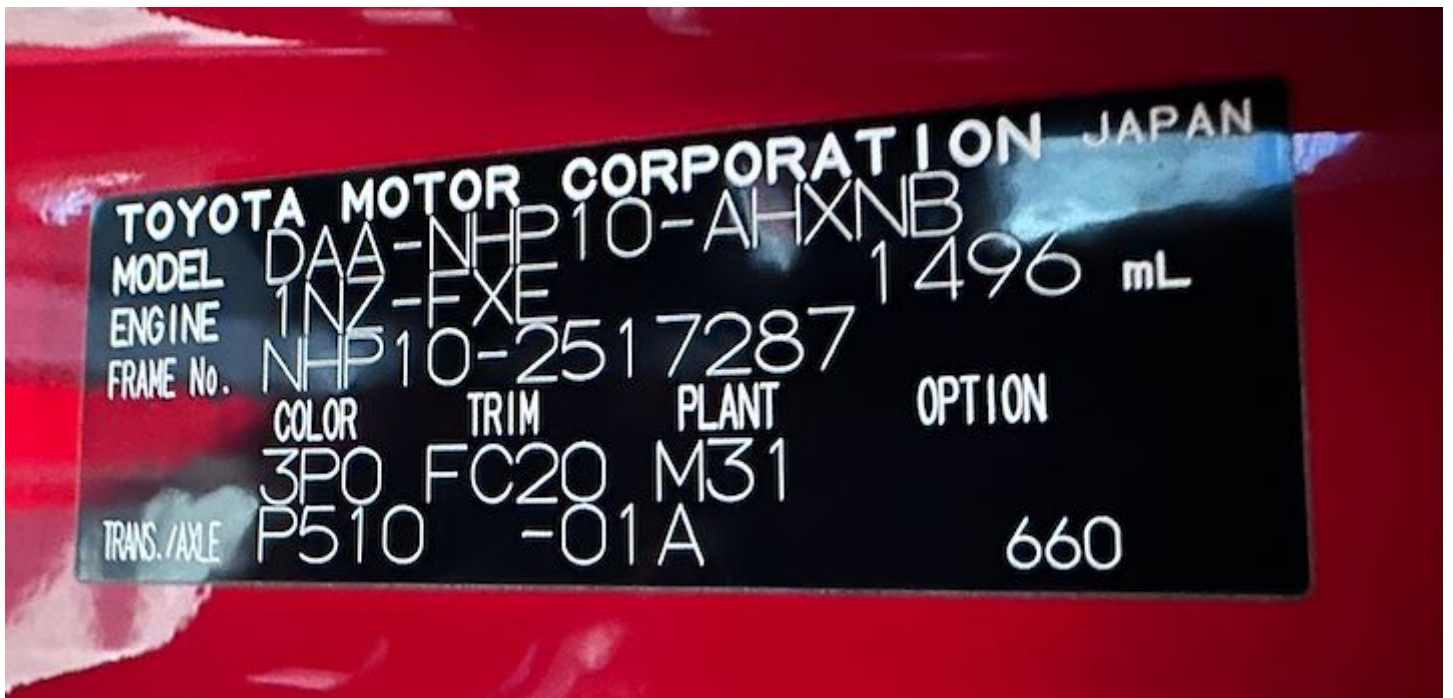


















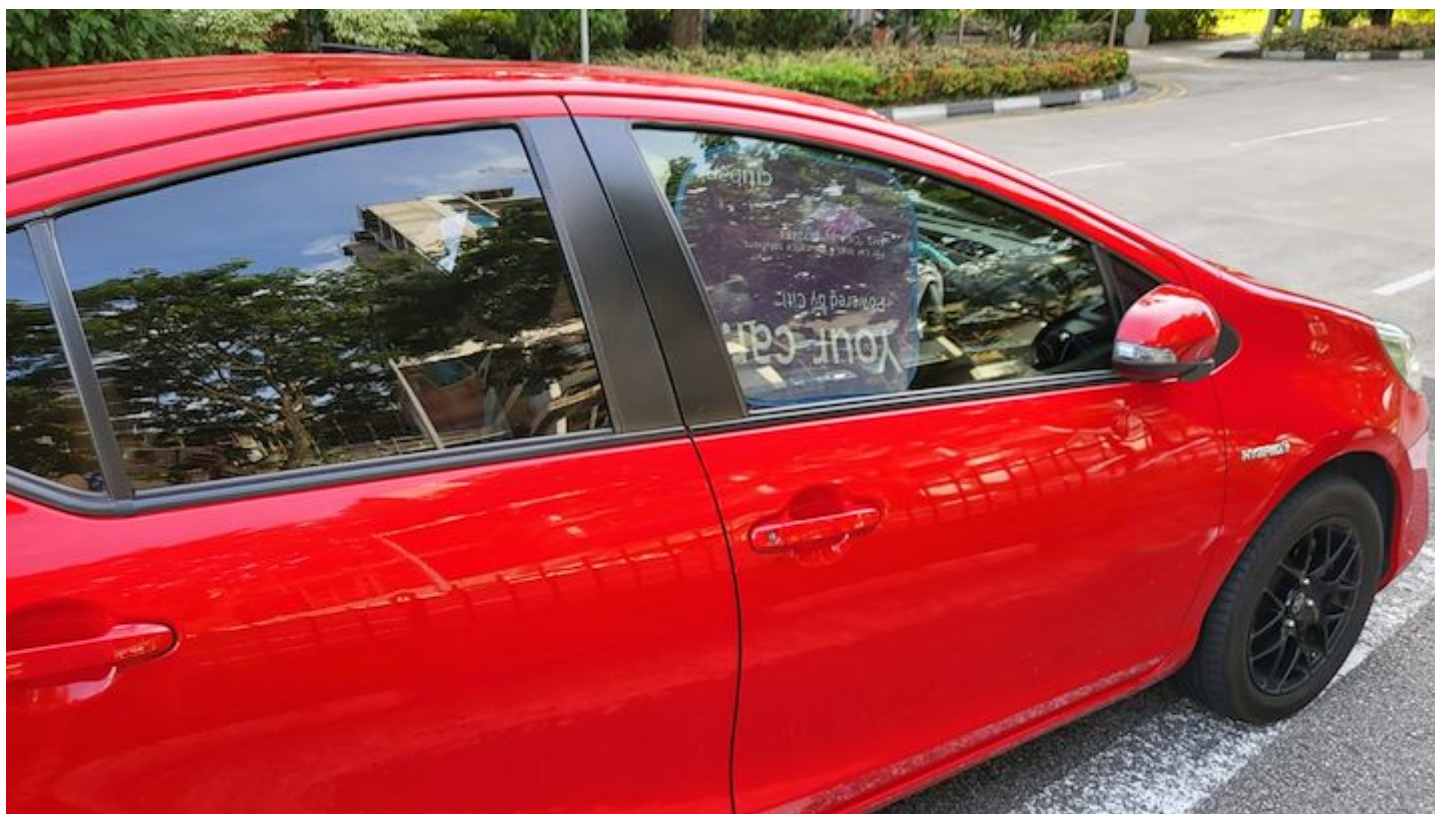

Brief Details.

On May 8, 2023 at about 5.12pm, I was driving my vehicle (SLD2303A) along 51 Upper Bukit Timah Road towards Hume Ave. My sister and daughter were in the car with me. My sister was sitting beside me and witnessed the accident completely. My daughter was sitting behind me.

I came out of the Bukit Timah Food Centre carpark and waited for the on coming cars to clear before driving into to the yellow box to wait. When the cars cleared, I drove into the first straight going lane. After that, I signalled right and move into the second straight going lane.

When I was in the second straight going lane, a vehicle (SNJ3330J) which is on the right turn only lane suddenly make a sharp turn left into my lane without signalling and without checking his blind spot. I immediately honked him but he still banged into me. I stopped and immediately put on my hazard light. The driver continued to move in front of me. He seemed to have the intention to hit and run. He did not stop at all and I kept honking at him and following behind him. After some time, he put out his hand to signal to the front. We crossed the traffic light and came to a right turn only lane. Still, he kept on driving without an intention to stop. When our vehicles had the chance to stop, he tried to drive off some more but I quickly got out of the car and ran to his car, tapping on it and asking him to stop as we have already drove off the accident site and should not be driving further. That was when he finally got out of his car. His left bumper hit my right mirror, top of my wheel and door. We took pictures of the car and he said to let the insurance settle. His insurer is Liberty. We also took pictures of each other's NRIC and driving license.

I told him I have a child in the car and he apologised before leaving.
