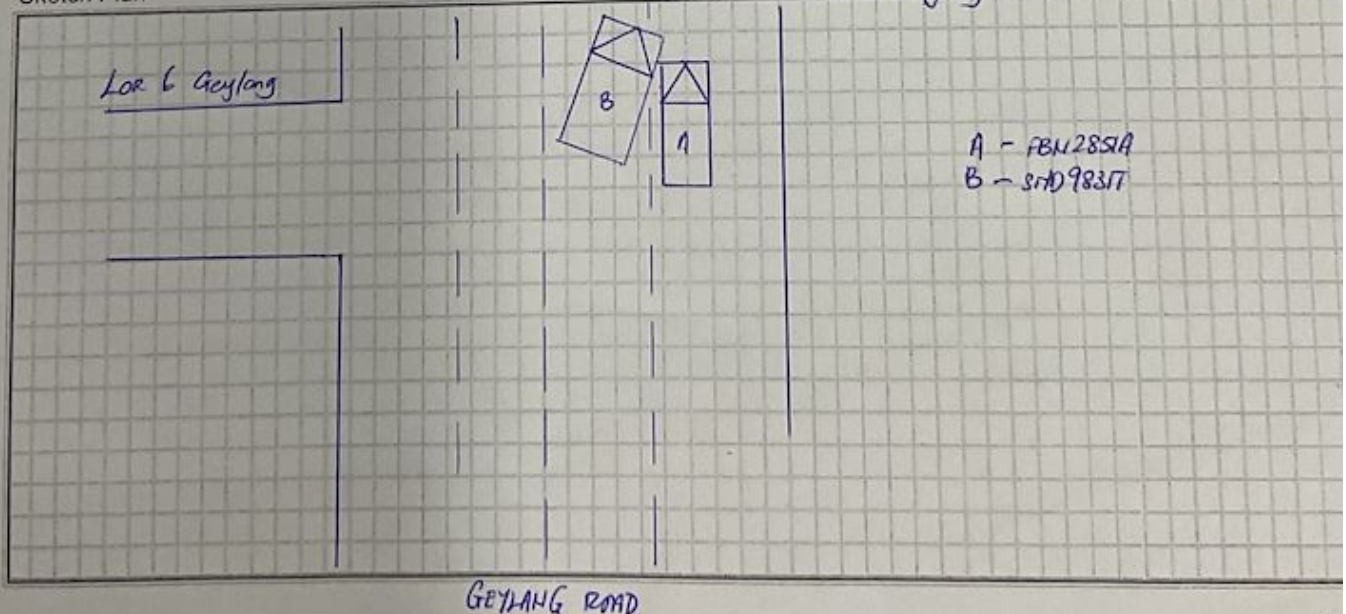

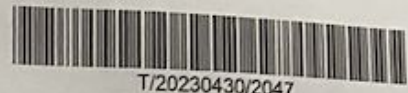

CONTINUATION OF REPORT**Brief Details.**

On 29/04/2023 at about 1150hrs, I was riding my motorcycle bearing registration number FBN2851A along Geylang Road towards Kallang Road. I was riding on the most right lane when suddenly one taxi with plate number SHD9831T came directly towards my left side. The said taxi had abruptly changed 2 lanes from the middle lane right towards mine.

Due to the taxi driver's action, I was forced to accelerate my motorbike and the right side of the taxi swiped the left side of my motorbike. I was still able to control my motorbike and stopped inches away from the taxi. I believed that the taxi driver had made a sudden decision to make a right turn at the junction ahead. He had squeezed from the middle lane when the vehicles in front slowed down due to red light.

We then alighted from our vehicle to exchange particulars. However, after giving him both my NRIC and driving license, he refused to give me his driving license. He only gave me his NRIC. The taxi driver kept telling me that the accident was due to my fault, and he had his in-car dash camera recorded. He then immediately told his male Chinese passenger to leave the scene.

After making calls from his mobile phone, the taxi driver came to me and ask I would want to settle the matter privately without calling the Traffic Police. However, when he saw the ambulance arrived, he went inside the vehicle, and he was trying to move the vehicle. The driver was advised by the paramedic not to get in the vehicle prior to Traffic Police arrival. While I was inside the ambulance waiting for the Traffic Police to come, one of the paramedics saw the taxi driver was trying to get in the vehicle again and was trying to meddle with the in-car dash camera. The paramedic then went out and told him off again.

Moments later, one police patrol car believed to be from Traffic Police came. I was then conveyed to Tan Tock Seng Hospital and received one week of hospitalization leave. I was diagnosed with left fractured toe and abrasions on my left knee. That is all.
