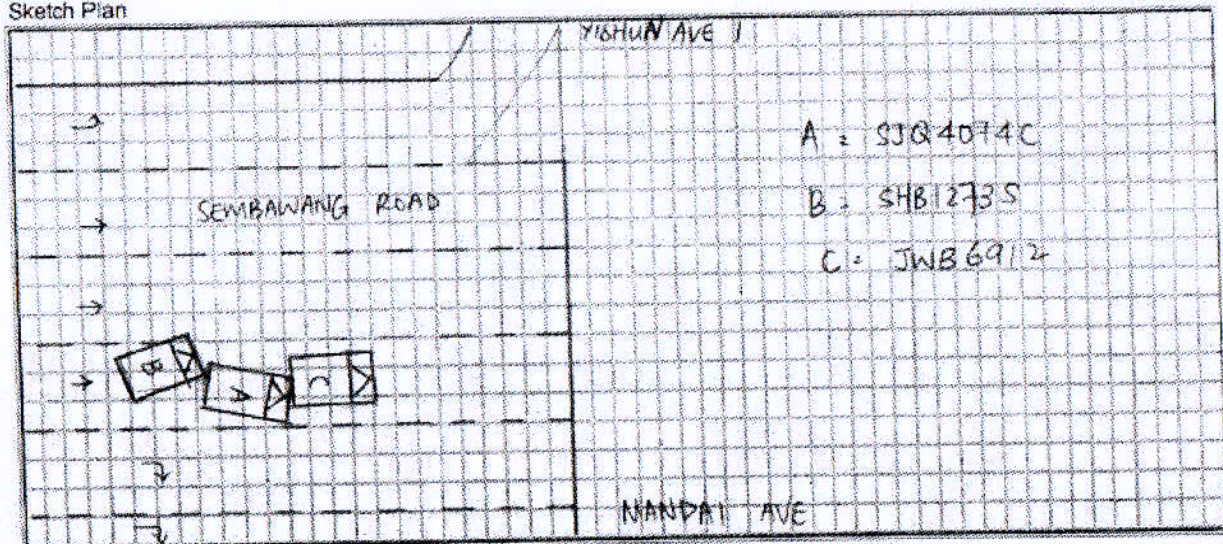

Brief Details.

On Saturday, 6th May 2023 at about 2.00pm, I was driving my car SJQ 4074C along Sembawang Road when the traffic light turned red. I stopped and was already stationary for about 30 seconds when suddenly there was loud bang at the rear of my car. My car moved forward from the impact and it hit the car in front of me, JWB 6912.

I was in shock and stayed seated for a few more seconds when the driver of the taxi SHB 1273S that had hit our rear, came to our window to check on us. I then saw him gave chase to a motorbike on foot to no avail.

He then approached my vehicle again to check on us.

He claimed the motorbike had 'hit and run' his taxi and decided to chase with his taxi but unfortunately hit our car instead.

Driver of taxi SHB 1273S was apologetic and admitted his fault.

Motorbike that allegedly had 'hit and run' his taxi had sped away.

I noticed a motorbike speeding away from the scene.

I had 4 passengers with me in the car.

My mother, front passenger seat - Suwariyah Binti Sarkawi [REDACTED]

My sister, back seat - Juliana Binte Abu Samah [REDACTED]

My fiance, back seat - Mohammad Hafiz Bin Mustafa [REDACTED]

My niece, most back seat - Adelia Raisya Bte Mohd Nazir [REDACTED]

We felt we did not require ambulance assistance at the scene, however we felt pain, strain and aches in our bodies developing after the adrenaline wore off.

We had sought medical assistance at which we were all given 3 days medical leave and a A&E referral letter in case our pain does not subside or intensify within these 3 days.
