

I have pictures exceeding 2MB related to the prior accident occurred on the fourth lane as I was driving my rental car, SLX2614Y on the BKE expressway near to the sign indicated as 500m, Exit 8 towards SLE (CTE/TPE), Turf Club Ave, Kranji Rd intending to head for Woodlands. As I came driving from the third lane at BKE, gradually forming up on lane 4 where the Subaru XV car in front of me SMJ3432K who is my friend was engaging his car brake intermittently. Maintain a following distance between my car at quite a safety distance with my car speed which I may have remembered to be either more than 80km/h or less and the car ahead of me, I noticed my rear view mirror that there are two motorcycle riders believed to be my friends. The intermittent brake from the Subaru XV in front of me went to an emergency brake whereby I instinctively had to engage my emergency brake. My rental car came to a halt and there was no collision from my front but a knock on my rear car can

be felt. I looked at my rear view mirror there was no one and as I checked my side view mirrors, my right side mirror can see a figure on the road who is very close to my rental car. Engaging my hazard light, handbrake, I ensured my four friends/passengers were safe and no injuries were afflicted to them. I noticed the motorcycle rider is my female friend, Nasuha Dhabitah on the road flat with her helmet still on and her bike, FBU5335S that was quite close to her. As I tried to call her name out, my friends eventually attended to her trying their best to wake her up as she was seen motionless upon notice. The right side of my rental car bumper can be seen as damaged along with the tail lights on the right and a chipped off part of the right rear tyre of the car. An ambulance was called on site then came along the traffic police, emas recovery and the LTA traffic rider. Particulars of myself, my rider friend Nasuha were recorded down on the accident site. I noticed there was a young Chinese man in his 20s to mid 30s who came to attend to the accident scene and volunteered as a witness. A Police Officer, Encik Nazrul have collected my dashcam memory card as evidence for the accident occurred. Upon clearing the accident scene, my rider friend Nasuha was brought to the nearest hospital, Khoo Teck Puat Hospital while I was instructed by the LTA marshall officer, emas recovery vehicle that towed my friend's bike and the traffic police officer car that guided me towards the expressway exit towards the Turf Club Ave so to clear the congestion on the BKE expressway.





TERMS AND CONDITIONS

Precursor Investments (hereinafter called "the owner" which expression shall where the context so admits include the owner's successors -in-title) hereby agrees to let and the hirer name herein (therein-after called "the Hirer") agrees to take on hire the motor vehicle described herein (hereinafter called "the said vehicle") subject to the following term and conditions.

1. The said vehicle (and all the tools and accessories therein) is the property of the Owner and the Hirer shall be a mere bailee thereof and no interest in it shall pass on to the Hirer.
2. The Hiring shall commence on the date and at the time stated unless extended or as expressly requested by the Hirer.
3. The Hirer shall pay in full the hire charge specified herein before the commencement of hiring. No part of such hire charge shall in any circumstances be refunded.
4. If the Hirer shall fail to return the said vehicle at the expiration of the period of hire, then without prejudice to the other rights of the owner, the Hirer shall pay to the Owner for every hour elapsing between the time of such expiration and the time the said vehicle is returned to the Owner, such further other charge in accordance with the owner current rate of hire charges or at such other rates as the Owner's may in its absolute discretion think fit. All charges and amount due which are not paid when due shall bear an interest of 1.5% per month until they paid.
5. The said vehicle may only be driven by the Hirer or the persons who have expressly designated and authorized therein (hereinafter called "the authorized driver"). The Hirer and the authorized driver must be in possession of valid driving license and shall at all times drive the said vehicle in a careful and skillful manner, observing the traffic regulations and laws and in the event of any breach thereof, the Hirer shall pay all fines, cost of repair and penalties which may incurred and shall also answer all Police and Traffic court summonses, Notice and Inquiries in connection therewith. Particular attention is to be accorded to the following.
 - a. There Hirer shall not carry load of passenger in excess of Motor Vehicle Licensed carrying capacity (i.e. one driver and four passenger)
 - b. The Hirer shall not drive the said vehicle whilst under the influence of intoxicating liquor or drug.
 - c. It is expressly forbidden to hire the said vehicle out to third person or let unauthorized person or learner to use the said vehicle or to permit the said vehicle to be used for illegal purposes (For instance in connection with theft drug pedaling or trafficking, smuggling or any other criminal activity) or the purposed of test or racing. 6. The Hirer agrees that a punctured tyre, empty petrol tank, flat battery due to negligence, loss of vehicle's keys or locked key inside the vehicle, by itself does not constitute a breakdown and that event the owner's 24 Hours Emergency Service is called upon to respond to such occurrence, the Hirer shall bear the cost of such response at \$100.00 per trip.
7. The Hirer or authorized driver shall report all accident involving the said vehicle to the Owner immediately and should there be bodily injuries also to the police not less than 24 hours after the accident. The Hirer or authorized driver shall not admit or compound any claim either partially or in full. Hirer is to secure the names and addresses of all witness as well as the registration number of all vehicles involved in the accident. All communication or letter received from the police or Third parties are referred to the Owner immediately. The Hirer shall not abandon the said vehicle without adequate provision for safeguarding and security the same time. Failure to comply with rules 5 and 7 will render the hirer liable for all cost and third party claims.
8. The Owner shall not under any circumstances be liable to make any payment to Hirer in respect of or to indemnify the hirer against any loss, injury or damage sustained by the Hirer or by Third party as a result of the use of the said vehicle or any defect therein and in taking delivery of the said vehicle the hirer shall be deemed to have satisfies himself that is in all respect roadworthy and in a proper and safe condition.
9. Booking fee is strictly non refundable. If for any reason the vehicle described in the schedule of any other vehicle ordered by Hirer prior to the commencement, the Owner shall have right to replace the said vehicle with alternative vehicle of similar seating capacity and performance and if no such alternative vehicle is available the Hirer shall be repaid any hire charge and deposit (if any) paid by him after offsetting the rental charge and cost incurred but shall have no other claim of any kind whatsoever against the Owner. However if no deposit is paid, the Hirer must pay for rental charges incurred on demand.
10. The Hirer Shall pay for the cost of petrol during the period of hiring PROVIDED ALWAYS that the Hirer having taken delivery of the said vehicle with petrol shall return likewise, failing which the Owner shall be entitle to refill the tank and the cost thereof shall be recoverable from the Hirer.
11. The Vehicle is NOT covered by motor insurance policy covering personal accident insurance for the Hirer, his passenger or authorized driver and the Owner shall not responsible for any liability claims, injuries or otherwise in connection with any accident death or the loses arising from the use of the vehicle. The Owner may at the request of the Hirer and upon payment of the requisite charges arrange for separate personal accident coverage for bodily injury or death.
12. The said vehicle shall be covered under a Vehicle Insurance Policy which contain an excess clause as stipulated / Stated in the current Owner's car Rental Standard brochure Tariff.
13. On or prior to the expiration of the period of hire, the hirer shall return the said vehicle together with all tyre, tools, accessories and equipment to the owner at any of the Owner's designated station in as good order and condition as the said vehicle was when collected by the Hirer from the Owner.
14. No relaxation, forbearance or indulgence by the Owner on enforcing any of the term and condition of the agreement shall prejudice or affect the rights and power of the Owner hereunder nor shall waiver or any breach operate as a waiver of any subsequent or continuing breach.
15. The Hirer is responsible for obtaining the required cash card with sufficient balance prior entry into any roads within the ERP system.
16. In the breach of the term and conditions of the agreement, the Owner reserves the right to resume possession of the hired vehicle at anytime from the Hirer in the Owner's interest without prejudice and a penalty of \$3000.00 will be imposed.
17. The Owner shall not be liable to Hirer or any person for any loss or damage whatsoever and howsoever caused or occasioned by reason of the Owner resuming possession of the vehicle nor shall the Owner be liable to any person for monies, good, article or things not belonging to the Owner which are in or alleged to be in the vehicle at the time the Owner resumes possession of the vehicle.
18. The Hirer shall not take the said vehicle outside mainland Singapore, Malaysia or any other territory outside Singapore without written consent of the Owner. Failure to comply with this term may entail serious consequences and the Hirer shall assume personal and full responsibility and in the event of the said vehicle being damage seized, confiscated or forfeited as result thereof, the Hirer shall indemnify the Owner for all losses incurred including the value of the said vehicle.
