Brief details.

I was on the 3rd lane from the left at the junction which was a turn left/straight lane. As I made my turn, a vehicle on the 2nd lane knocked into my car as he went straight, even though he was on a Turn Left Only lane. I stopped my car right after the turn and looked back to see if he would stop his car but he drove off. I have dash cam video footage that shows the vehicle number as a Mazda SLP9640S, as far as I can see. There are other possible witnesses to this incident, as my dash cam also captured 2 other vehicles that were behind the car that knocked into mine. One was a Blue Comfort Taxi SHC7095L (what I could tell from the footage) that was right behind the Mazda, and I believed his car dash cam would have captured the entire incident. The car behind the taxi was a Honda SLU5335Z. As my car was much
