Brief Details.

On the stated date and time I was travelling along the stated location (pie towards tuas before adam road exit) on my vehicle SLW2928Y, when suddenly the vehicle ahead braked hard. Suddenly, there was a huge impact from the rear of my vehicle, which propelled my vehicle forward, causing my vehicle to collide into the vehicle in front of me. When I alighted to check, I realised I was involved in a three car chain collision and I was the second vehicle. The order of the vehicles involved is as follows

1. SLU3535B
2. SLW2928Y
3. SLS1975M

I later went to a GP at Toa payoh unihealth 24h clinic because I felt pain in my neck area, lower back, lower right hip, right shoulder where I received treatment for the injuries sustained during the accident, I was given 3 days of mc starting from 14 may, and medication.
