

Just before 4 pm on Sunday, 14 May 2023, I turned off Farrer Road into Holland Road towards Orchard Road. The conditions were clear and dry. My car is EJ7171G.

As I was entering Holland Road, I noticed a white car about to enter Holland Road from a side road, so I moved into the middle lane. I was travelling at between 50-60 km/h. The white car came out and did not stay in the left lane but began to move across into the middle lane despite my being on that lane. It did not stop doing this even though I horned at it. I was braking to slow down even as I horned at the white car. I was moving quite slowly by this time. As I tried to move right to avoid the white car, my car clipped it and was hit from behind. I cannot be sure whether my car clipped the white car first before being hit or my car was hit first and then clipped the white car.

The car that hit me from behind was a black MPV. I had noticed it earlier on Farrer Road driving quite fast behind me on the left lane. It was held up on that lane and entered the slip road to Holland Road behind me.

I stopped on the right lane and came out and took photographs of the white car (SMH9730X) and the black car (SLN126E). The driver of the white car was an elderly Chinese male who spoke Chinese with a PRC accent. He seemed to be bewildered. There was a female passenger in the front passenger seat of the white car, but she did not get out. The driver of the black car was a middle-aged Chinese man who seemed to be local. The front number plate of the black car had fallen off and the front of the car was so impacted that the engine could be seen. The driver of the black car claimed loudly that his car was immobile. There was a female passenger in the front of the black car. She did not get out of the car. I took photographs and after the two other drivers took photographs of my car, I told them I had to leave to pick up my daughter.

She is eleven years old and was at a ballet class at Forum Galleria.
