**Sketch Plan**

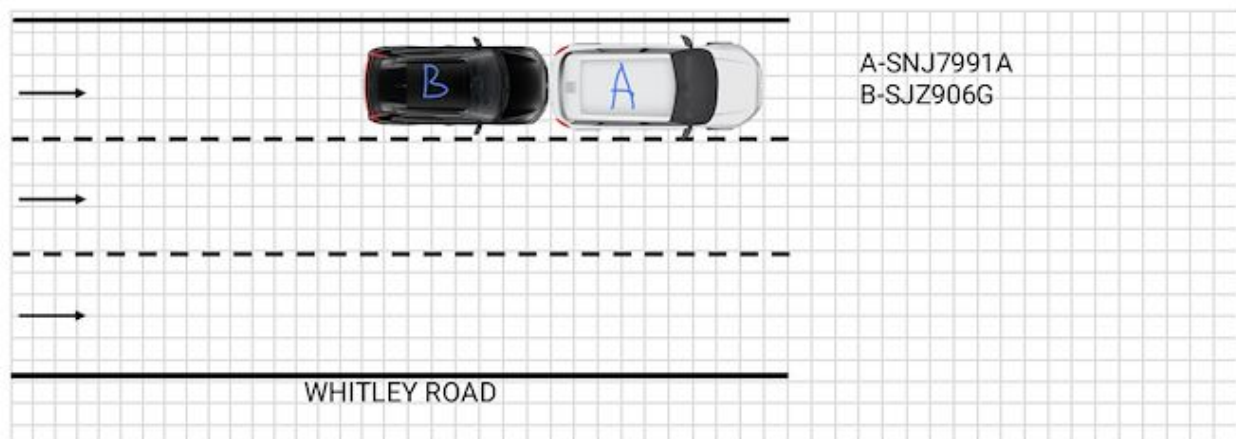
