

**Describe Circumstance of the Accident**

On 15 May 2023 at around 11pm: I got into an accident with a Prins. I was about to turn my car out of a parking lot by the side of the street (Ayed Mari Road). I turned my steering wheel to the right and was just starting to move when the Prins came from behind at very high speed. The Prins hit onto my wheel and his hub cap fell off. The side of his car was also damaged. He only came to a stop after 2-3 cars stopping distance - indicating his high speed of travel.

My car is largely undamaged - only the hub cap had some scratches. Ayed Mari Road is very narrow with cars parked on both sides - he should not have been traveling at such high speed.

When I had checked the rear mirror before ~~turning right~~ moving I did not notice his car heading towards me.
