



Accident Nanhua Primary school 17 May 2023 @ 730am

The accident happened after the drop off bay of the school. The drop off bay is a two lane roundabout. After dropping off kids, cars can filter into the outer lane if cars in the left drop off lane in front are slower in having their kids disembark. This is to ease up space for cars behind to move into the drop off lane and generally facilitate a faster drop off procedure.

On nearing the exit, the two lanes merge into a single left turn lane.

I, driving, SLE86J filtered out after dropping my kid off and proceeded on the outer lane. At the merge point it was clear for me to merge and turn left. Another car, SNB5187K, on my left rear decided that he had the right to move ahead even though I was way in front fully visible to him. He had full frontal visibility of the situation at all times. On my making the turn where it was already a one lane capacity, both cars contacted because of the intentional protrusion of SNB5187K into my rear left blind spot resulting in damage.

The driver of SNB5187K insisted he had the right of way. If that were true and I kept any more right, I would have to take up the space of the oncoming lane. Speed at the time was about 5kmh. Conditions dry. Visibility good.
