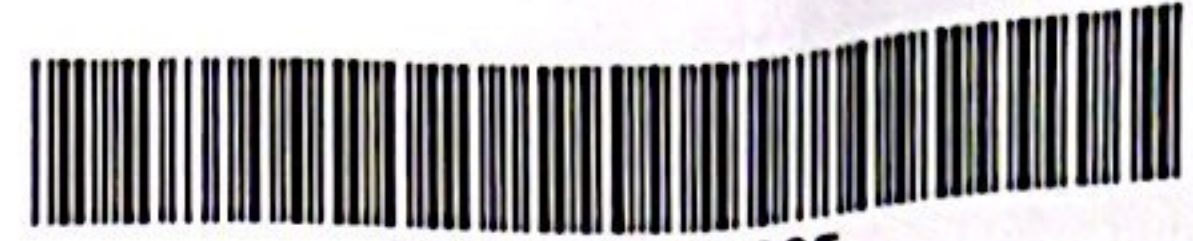

Brief Details.

On 18/05/2023 at about 1715hrs, I was riding my bike JTQ7205 along Senja Road towards Bukit Pangjang Ring Road, on lane 1. At the point of time, one ComfortDelgro taxi was on lane 2, slightly in front of my motorcycle.

Suddenly, the said taxi hit onto my motorcycle from my left side which caused me to lost control and fall onto the ground, when it was near to the carpark entrance of Blk 656 Senja Road.

I called for Traffic Police and Ambulance assistance as I was in pain and my limbs also bleeding.

While waiting for Traffic Police arrival, male passenger of the said taxi told me that actually he was heading to Blk 656 Senja Road. He also informed that before the collision the said driver was changing lanes from Lane 3 to Lane 2 and intending to change to my lane (Lane 1) to enter the carpark of Blk 656 Senja Road. The said passenger then left the scene before Traffic Police arrival.

The paramedics checked on my injuries and suggested to convey me to hospital for further checks. I rejected the conveyance as I still felt ok and I wanted to go to clinic on my own thereafter.

The left side of my motorcycle was damaged badly and the body also dropped out. My friend assisted to call for a private towing before he sent me to clinic.

I sustained abrasions at my shoulder and limbs and feel pain at my neck and lower back area.

I went to Unihealth 24-hr Clinic (Jurong East) to seek treatment on my injuries and was given 5 days MC from 19/05/2023 to 23/05/2023 inclusive. I was also referred by the Doctor to hospital for x-ray screening.

There was no dash cam installed on my motorcycle.
