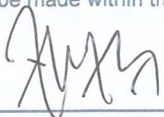

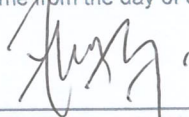

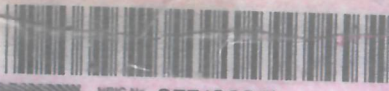
Sketch Plan

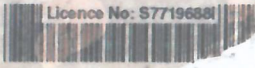
