**Brief Details.**

On 19/05/2023 at about 1300hrs, I was driving a lorry (V1: YK5522Z) along Kaki Bukit Place (nearest to Kaki Bukit Avenue 3) with my attendant in the passenger seat. After passing by a stationary car (V2: SJX3343X) in the last parking lot before the junction of Kaki Bukit Road 3, my attendant alerted that V2 sounded its horn and was flashing its high beam towards V1. I stopped V1 by the side and approached V2's driver who was standing outside his car. The driver told me that V1 had brushed against his right side mirror. I saw some scratches on V2's right side mirror but there were no damages on V1's left side. V2's driver claimed to have a video recording of the collision in his in-car camera but did not show it to me.

After exchanging particulars, V2's driver wanted to call the Traffic Police. As I had to rush off for a delivery, I told V2's driver that I need to do a delivery nearby at Kaki Bukit Avenue 3. I left for the delivery and later returned, seeing Traffic Police officers and an ambulance there. The Traffic Police officer later provided me with a case card and I subsequently left.

Both my attendant and I are not injured. V2's driver did not complain of any injury to me.
