ON 23/05/2023 @ 1325HRS, MY VEHICLE A (XD2262S) WAS STATIONARY AT SUMANG LANE. I ALIGHTED TO CHECK ON THE BLOCK TO LIFT MACHINE. AFTER THE SEARCH, I WENT BACK TO MY VEHICLE A (XD2262S) TO REVERSE BACKWARDS TO THE SERVICE ROAD. I CHECKED THE BLIND SPOT AND IT WAS CLEAR TO PROCEED. I SLOWLY REVERSED AND SUDDENLY A FOREIGN WORKER FROM THE OPPOSITE LANE WAIVED AND SHOUTED. I QUICKLY STOPPED MY VEHICLE A (XD2262S). I THEN DROVE FORWARD AND ALIGHTED TO CHECK. VEHICLE B (SMG4651D) DRIVER TOLD ME THAT HE WAS DRIVING OUT FROM THE SERVICE ROAD AND MY VEHICLE A (XD2262S) COLLIDED ONTO HIS VEHICLE B (SMG4651D) AND OUT OF HIS CONTROL. THE FORCED PUSHED HIS VEHICLE B (SMG4651D) BACKWARDS.

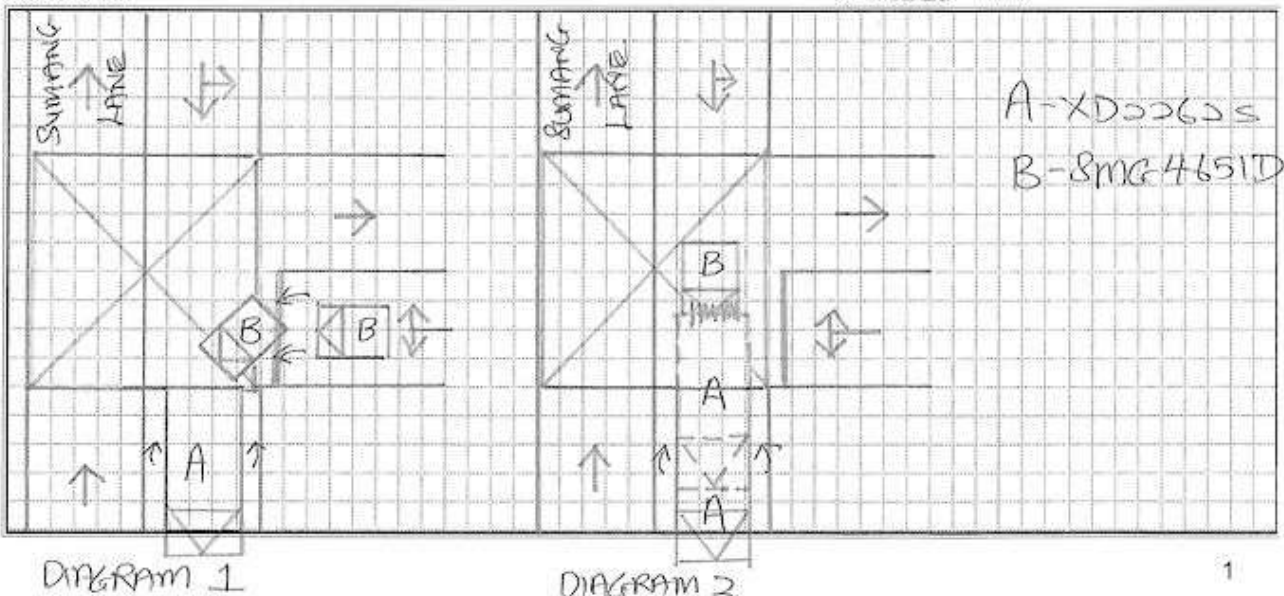
