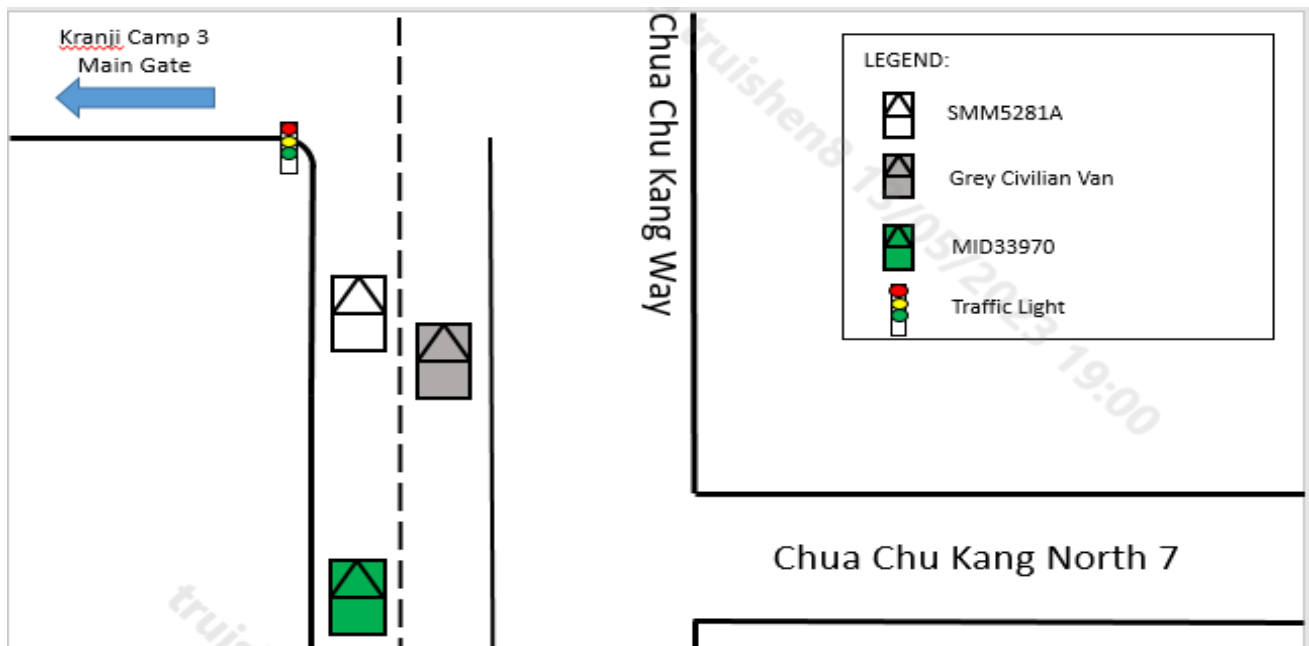


Figure A-1: Schematic of incident

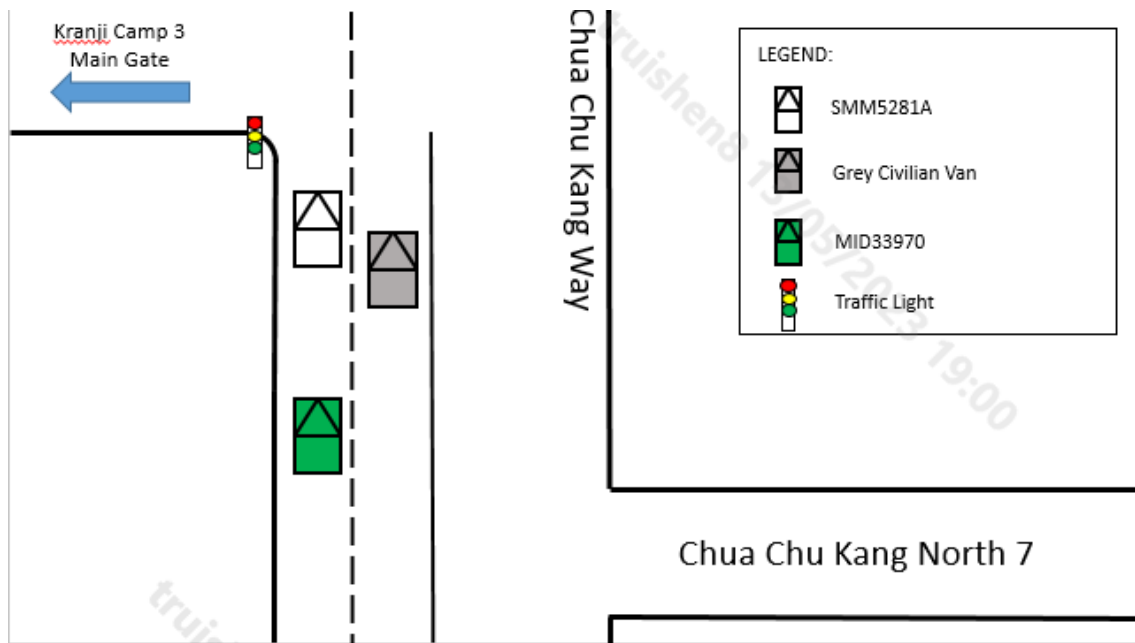


Figure A-2: Schematic of incident

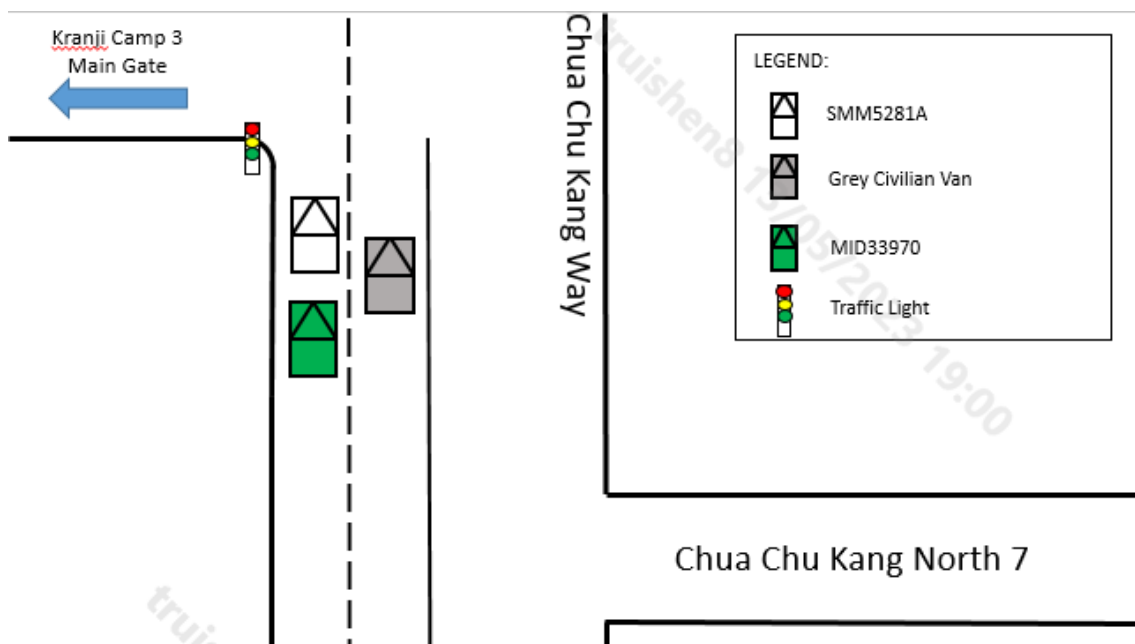


Figure A-3: Schematic of incident

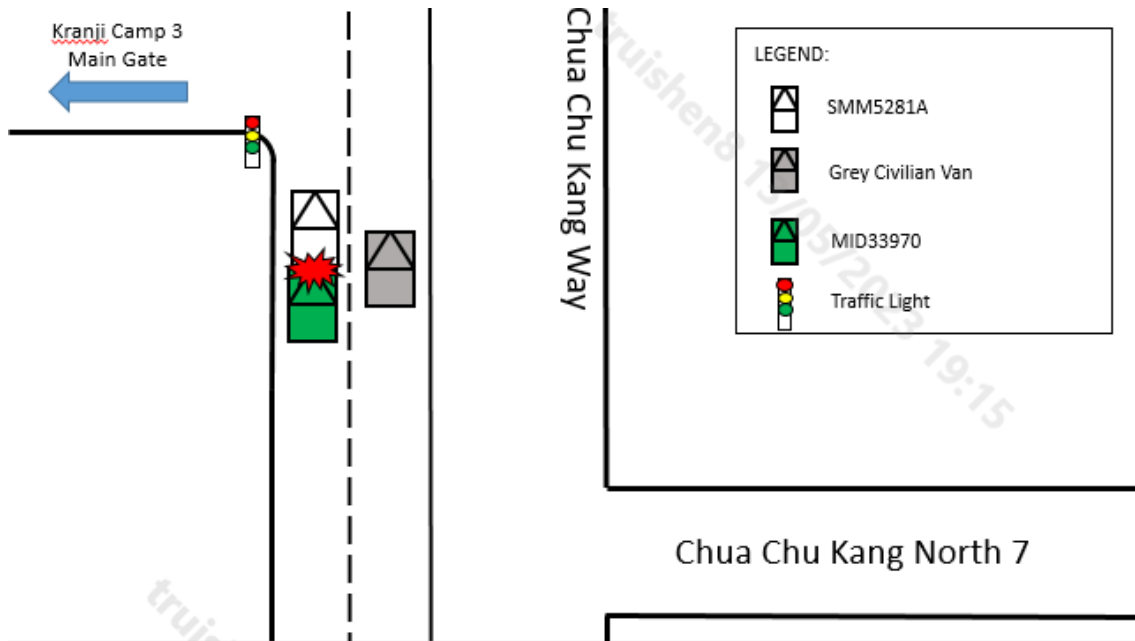


Figure A-4: Schematic of incident

However, i may misjudged the braking distance and bumped a civilian vehicle (SMM5281A).

Both me and the civilian were unharmed. The OUV was not damaged, but the civilian vehicle suffered a slight dent. Both of us came out of the car to exchange personal particulars, and the civilian driver said to contact him with regard to compensation for the damage.

Following the incident, I drove the OUV back to KC3 and safely parked down the vehicle at 2 SIR's Battalion Line at 1415hrs.

At 1415hrs, verbal report was also made to GSOC and the relevant authorities i.e. 1 TPT have been informed. The unit will stand advised on the follow up actions on compensation and convene an investigation on the cause of the incident.

I only have the photo of the damaged bumper of the civilian veh, while the civilian driver took all 4 side. however, he was not cooperative in sending his vehicle photo

Background Information

I stayed in camp the night before and had sufficient rest before operating the OUV. i have completed his MT-RAC, and was not distracted while driving i.e. not using his phone.
