

Brief Details.

I was driving on first lane on CTE towards SLE near Ang Mo Kio area. I saw from the rear mirror 2 traffic police on bike with their blinkers on and coming from the rear at high speed. (I have a video to show the other TP exit Seletar west link, exit 16, at a fast speed). I proceed to give way to switch to center lane and when I have completed my lane changed, the car in front of me brake and slow down as there is another motorcycle cut into his lane. Hence I have to slow down too in order to maintain a safe distance. It was at this moment I saw the traffic police (3SGT NG GUO WEI) didnt slow down in time and hit the rear right of my car. He was not riding at the center of the lane when the accident happen hence he have hit the rear right. I wind down my driver side window and shouted to inform him he have hit my car. He then told me to stop by the road shoulder. When I get off the car, he asked for my driving licence and IC and I thought he was going to penalise me. I asked him why is he faulting me when he is the one who hit my car on the side. He explained to me this is for exchange of particulars since this is a traffic accident, He also apologised to me that this was his fault. Subsequently we waited for the other police office to arrive at the scene to
