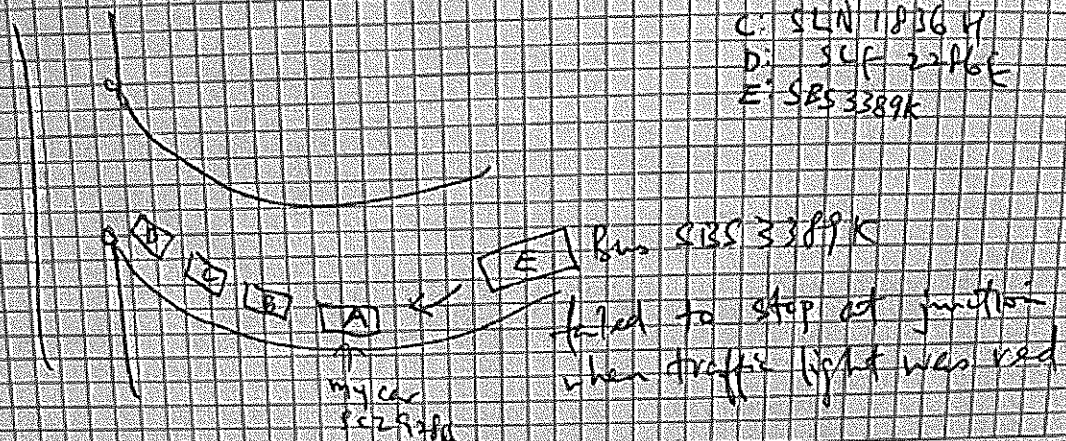

On 27 May at about 12 pm. Traffic light ~~was red~~
4 cars stopped at traffic junction (red light).
Bus SBS 3389K failed to stop and hit 4 cars.

My son, daughter & wife were inside the car during impact. My son Nicholas Tan had headache immediately after the impact. He didn't want to see doctor immediately as he said he is okay. But for safety reason, I brought him to see doctor this on 28 May morning & doctor gave him 4 days MC to monitor his situation.
