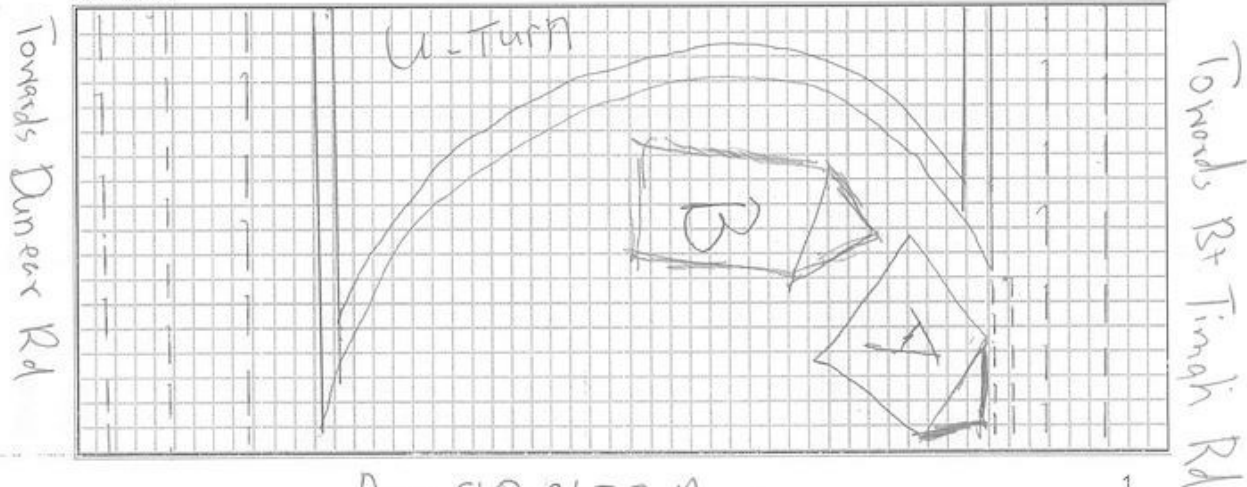

Describe Circumstance of the Accident


On the 26th of May 2023, around 0430pm, I was driving home after work. I was driving from Duneen Road, and I need to take a U-turn to turn into Bulkef Timah Road.

The U-turn I took was the U-turn that is opposite Royal Green Lando. I was the first vehicle coming out of the U-turn. As I was trying to ensure safe exit from the U-turn by checking vehicles coming on the main road (Bulkef Timah Road) on my left, I felt a sudden huge impact from the rear of my car. I stopped and checked what happened, and realised that a vehicle (SMR 2600 G) hit the rear side of my car.

Limitations As To Use

ExcelDrive Workshops and Accident Reporting

All accident repairs to the Motor Vehicle must be carried out at ExcelDrive Workshops, otherwise the claim is not payable under the Policy. For ExcelDrive Prestige Plan, accident repairs to the Motor Vehicle can be carried out at any workshop other than ExcelDrive Workshops.
