I would like to report a hit and run at the Malaysian customs. I have dash cam footage of the incident. The vehicle SLW7054K driven by S0133841B side swiped my front right bumper. The driver did not exit his vehicle and continued driving even after I brought down my window to speak to him. As it was directly at the Woodlands entrance of the Malaysian CIQ, I did not want to block traffic as there were many vehicles entering the CIQ. After clearing Malaysian customs, I put on my hazard lights and waited for the vehicle at the side road to exchange particulars with the driver. The driver drove past me and sped off after noticing I was waiting for him. I then chased him down and caught up to him at the middle of the causeway. As I pulled along side him and signalled him to stop by the side of the road, he sped up and refused to stop.

His passenger in the front seat saw my gestures and refused to acknowledge me. As we pulled into Singapore Woodlands CIQ, I informed the ICA officers of the incident. They apprehended the driver but he still refused to get out of the car to exchange particulars for insurance claim purposes. The driver was then not allowed to exit the passport check area.
