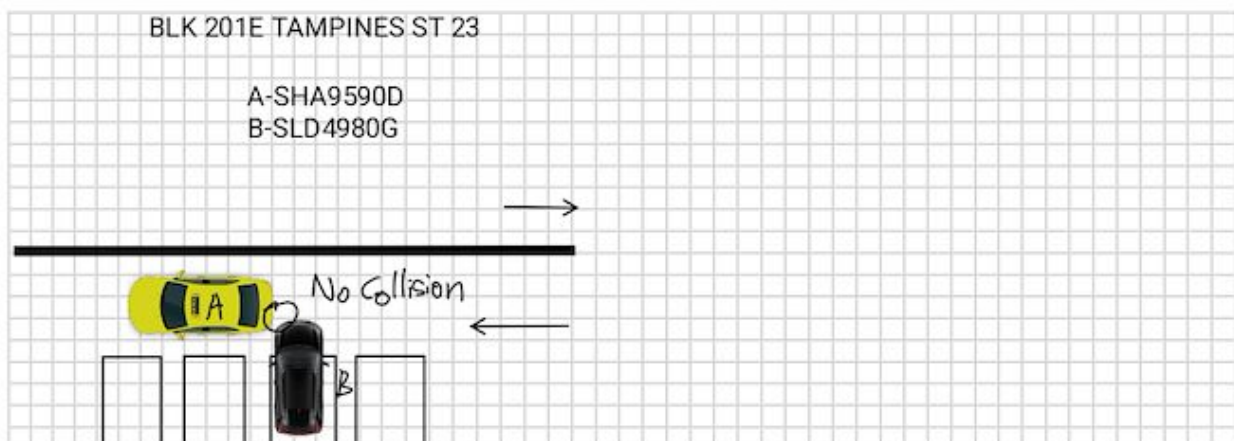

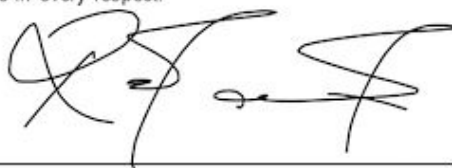
Sketch Plan
