I was in the midst of boarding and alighting passengers at B/S95109 Changi Airport PTB 3, when I suddenly heard a movement rock my bus. I alighted my bus and found out that SBS6465D (GAS) on Service 36 had hit the RHS rear of my bus and I reported to BOCC about the incident. There were 50 passengers onboard at the time of incident.

Damage:

SBS6465D (GAS): Left side panel behind rear door scratches

SMB1334R (TTS): Right side rear brake light covers broken and rear right body scratches

The bus is equipped with 360-degree cameras and CCTV in operation at time of incident.

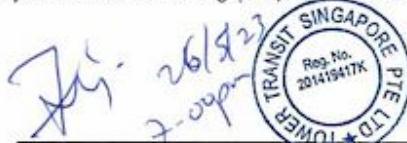

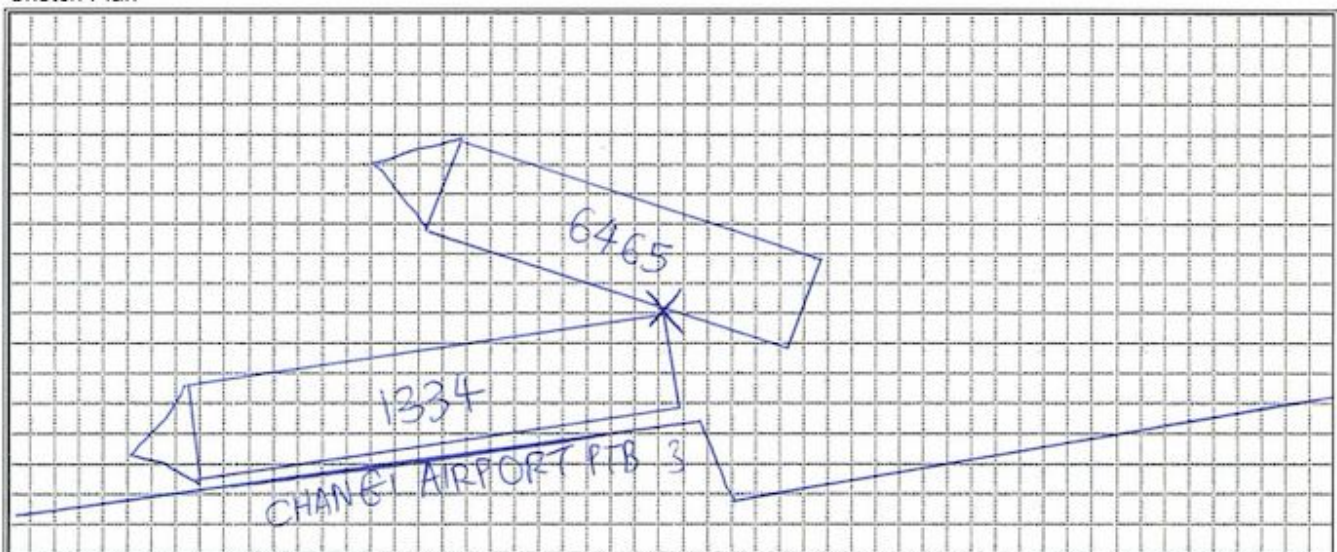
