CIRCUMSTANCES OF ACCIDENT

I WAS GOING HOME AFTER WORK. ON YISHUN AVENUE 2, NEAR DARUL MAKMUR MOSQUE, THE DRIVER OF THE LORRY IN FRONT OF ME SUDDENLY BRAKED. I ALSO BRAKED SUDDENLY. MY CAR COLLIDED WITH THE LORRY IN FRONT WITH A BANG. I WAS IN SHOCK AND COULD NOT UNDERSTAND WHAT SUDDENLY HAPPENED. WITH TREMBLING HANDS, I TOOK SOME PHOTOS AND THE DRIVER'S PHONE NUMBER.

I WAS CONDUCTING A TRAINING AT A CLIENT LOCATION ON MAY 29-30 DURING THE DAY. I WAS TRAVELLING FROM MAY 31 TO JUNE 4 AND WAS OUT OF SINGAPORE. I ONLY RETURNED ON SUNDAY (4-JUNE-2023) AFTERNOON. THEREFORE I COULD NOT REPORT THE INCIDENT EARLIER.

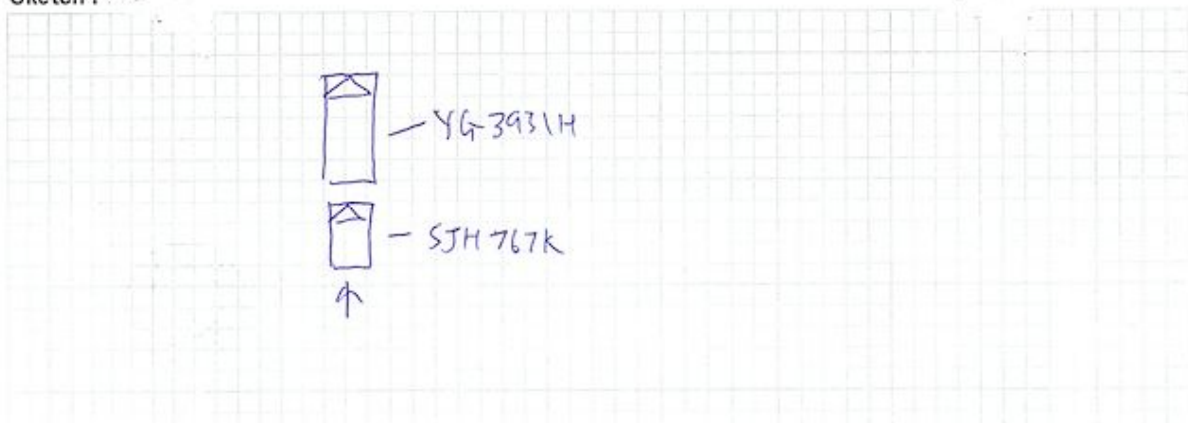

Describe Circumstances of the Accident

I was going home after work. On Yishun Avenue 2, near Darul Makmur Mosque, the driver of the lorry in front of me suddenly braked. I also braked suddenly. My car collided with the lorry in front with a bang. I was in shock and could not understand what suddenly happened. With trembling hands, I took some photo and the driver phone number.

I was conducting a training at a client location on May 29-30 during the day. I was travelling from May 31 to June 4 and was out of Singapore. I only returned on Sunday June 23) afternoon. Therefore I could not report the incident earlier.
