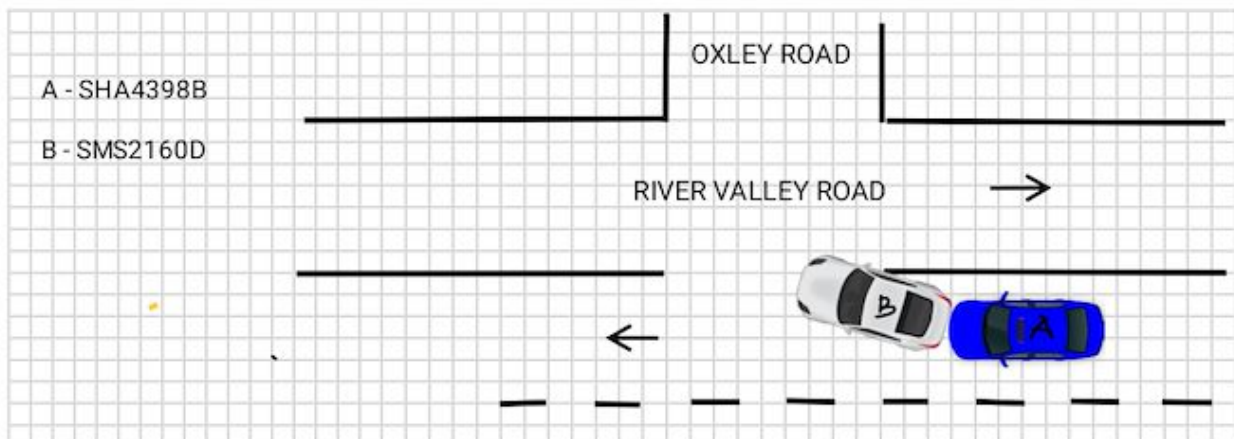
Sketch Plan


