Brief Details.

On the 30/5/2023 at about 1600hrs while I was working, I parked my van bearing plate number JVS3583 a Malays an Registered vehicle along the road of Greendale Rise. While I was resting in the van, I noticed a car bearing plate number SGF810P came in front of me and stopped. Subsequently I saw the driver exited the vehicle and walked towards 4 Greendale Rise. I then noticed the car slowly rolled back, gained speed then subsequently collided into me. After colliding into me, the car continued to roll back then went downhill and went crashing onto the tree. Thankfully no one was on to the path of the vehicle, no other properties were damaged. The car managed to stop only when it collided onto the tree. The driver and I went over to his car to take a look and indeed saw the car was on "Parked" and its handbrake had engaged. I am unsure what had happened that caused the car to roll back. It was not raining and the road surface was dry.

My van sustained damages on the right front side. My headlight and my front right bumper including my driver door was damaged. My body is aching but I have yet to see a doctor. I am planning to see the doctor.

Both the driver and I managed to exchange particulars and lodging the report for insurance purposes. I wish to add that no other parties was involved in the accident.
