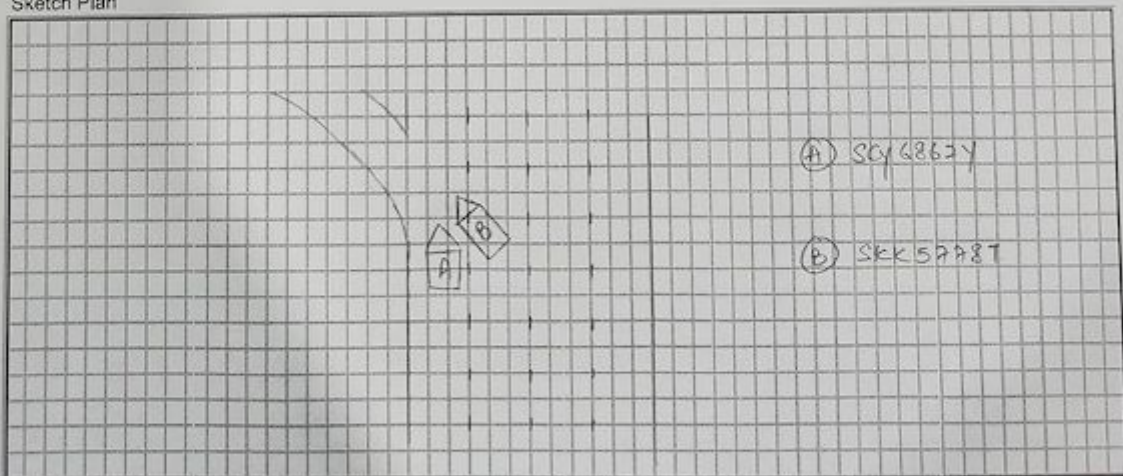

Sketch Plan



NOBODY WERE INJURED.


