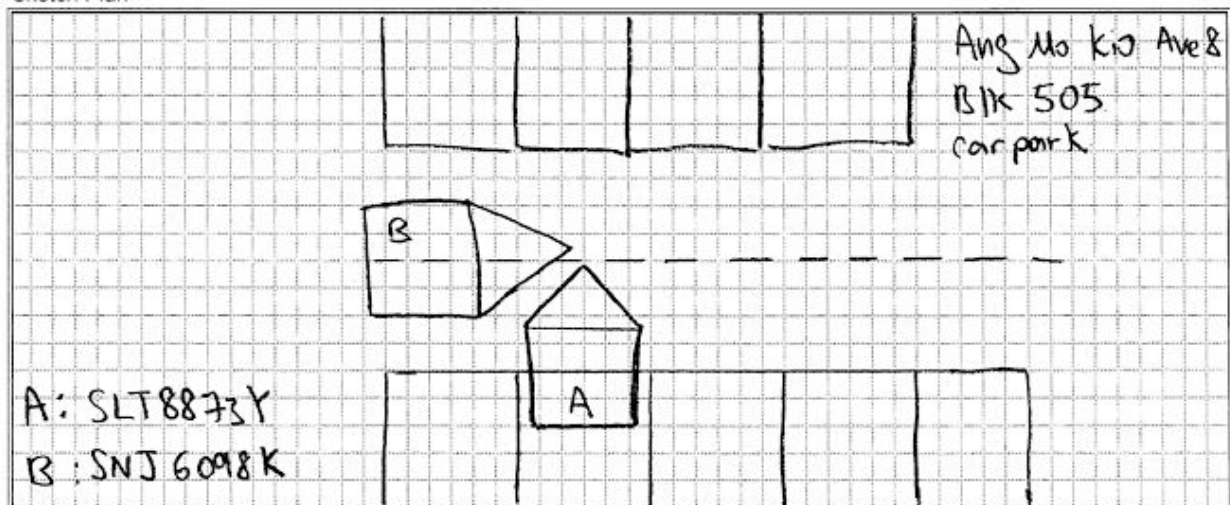

## Describe Circumstance of the Accident

On the 1st of June 2023, I was parking my car at the carpark of BIK SOS Ang Mo Kio Ave 8 around 1.23pm. I went into the parking lot backside in and was waiting for the other cars to pass before moving forward to align my vehicle into the parking lot.


I moved forward, stopped and shifted my gears to reverse, vehicle SNJ 6098K went past me at high speed to drop off his passenger nearby. In the process, he swiped my front number plate and it fell out, damaging and scratching my front bumper in the process.

Upon inspection of the taxi, he sustained light scratches on the right side of the vehicle, and a slight dent on the front wheel area.
